The Look after arrangements in JAG in respect of above DEs/AGMs is in the interest of service and subject to the following conditions:

- (a) The arrangement will enjoin upon the Executive to shoulder the responsibility matching his pay scale under the EPP in the interest of service.
- (b) No extra remuneration will be paid.
- (c) The service in higher grade under this arrangement will not count for any benefit in matters of future promotion, seniority etc.,
- (d) Executive manning higher post, in this manner is given functional powers (Administrative and Financial) attached with the post.

....

- (e) This will only a stop-gap arrangement till a regular arrangement is made.
- (f) Further, the Look after arrangement is also subject to the following guidelines stipulated in BSNL Hq. No. 400-204/2013-Pers.I dtd 01.11.2013:
- (i) A BSNL employee should be willing to accept higher responsibilities through promotions as decided by the competent authority.
- (ii) Refusal of promotion is not a right of the executive. Any order of promotion may not be refused by the executive normally.
- (iii) In exceptional cases, an executive may request in writing for refusal of promotion with sufficient reasons. But the request in writing for refusal of promotion shall be effective only with the concurrence of the Appointing Authority after taking all the aspects into considerations.
- (iv) If the reasons adduce for refusal of promotion are accepted by the Appointing Authority, the executive will not be considered for any promotions (either regular or adhoc promotions or even look after arrangement) for a period of one year or till the preparation of next panel which ever is later from the date of such refusal.
- (v) In the case of regular promotion being refused by the executive and refusal being accepted by the Appointing Authority, on the eventual promotion to the higher grade, such an executive will loose seniority vis-a-vis his junior promoted to the higher grade earlier.
- (vi) In case where the reasons adduced by the officer for his refusal for promotion or not acceptable to the Appointing Authority, then the promotion order shall be enforced upon the executive through an order. If the executive still refuses the promotion, then even disciplinary action can be taken against the executive for refusing to obey the orders.
- (f) The look after arrangements in JAG Grade is for a period up to 31.05.2015 or till a regular incumbent joins or until alternate arrangements are made whichever is earlier.
- (g) In respect of officers who are due for retirement before 31.05.2015, the looking after arrangements in JAG of ITS Gr. 'A' are for a period upto their date of retirement or till a regular incumbent joins or until alternate arrangements are made whichever is earlier.

- (h) The officer ordered on look after arrangements in JAG Grade shall report for duty at the place of postings within 10 days from the date of issue of this order. The Controlling officers/Unit Heads are requested to see that the officers are relieved immediately.
- (i) In case any Vigilance/Disciplinary case is pending/contemplated against any of the officer or any punishment like stoppage of increment is current, the look after arrangement should not be given effect to in respect of the officer and the fact should be intimated to this office immediately.

As per BSNL Hq order No. 412-13/2013-Pers.I (Pt) dated 26.06.2014, the look after arrangements entitles the officers that whenever a post being manned on Look after basis, statutory function shall move to the next higher level i.e., a GM in case of DGM or a DGM in case of DE or a DE in case of SDE.

The above arrangement is purely temporary and is likely to be withdrawn at any time without assigning any reason.

Any request for change of posting will not be entertained.

Necessary charge report may be furnished to all concerned.
