Sub:- Officiating promotion in the cadre of JTO- Reg.

Ref :- This Office ltr no. HRDII/2-1/OCT-2014/54 dtd 01/10/2012.

In accordance with BSNL letter no. 5-4/ 2004/ Pers IV dtd 13/05/2004 and in continuation of this Office ltr under reference, the General Manager (HR/A), Karnataka Telecom Circle, Bangalore is pleased to issue the local officiating arrangements from TTAs (who have qualified under 35% quota and completed phase I of JTO training) to the cadre of JTO as per the details contained in the Annexure with effect from 10/10/2014.

The officiating arrangements ordered are made in the interest of service and subject to the following conditions :

I. The officiating arrangements ordered are for a maximum period of 170 days w.e.f 10/10/2014 to 28/03/2015 or till a regular incumbent joins or until alternate arrangements are made, whichever is earlier. They may be reverted to TTA cadre positively on the last working day of the Officiating arrangements without awaiting any instructions from this office.

II. In respect of TTAs who are due for retirement on or before 28/03/2015 the officiating promotion in JTO cadre is for a period up to their date of retirement or till a regular incumbent joins or until alternate arrangements are made, whichever is earlier.

III. Disciplinary /Vigilance clearance may be obtained for all the candidates. In case any disciplinary/vigilance case is pending against any of the TTA listed in the Annexure I & II, promotion should not be given effect to and full facts should be reported to this office

IV. The TTAs ordered on officiating promotion shall report for duty at the place of postings on or before 29th October 2014. All the controlling officers are requested to see that the TTAs ordered on officiating promotion are relieved immediately to expedite implementation of the orders in the interest of service and the relief should not be held up under the plea that he/she has represented for change of posting or any other reason except for declination for promotion. The leave if any requested by the official under officiating orders should not be allowed.

V. If the TTA does not report as officiating JTO, with in the due date i.e 29/10/2014 Officiating orders of the official is deemed to be cancelled automatically and it will be presumed that the official has declined the promotion.

VI. SSA Heads are directed to transfer the TTA who is under promotion as Officiating JTO in the substantive cadre i.e., TTA to the place where he is proposed to be posted as officiating JTO. TA/DA should not be paid to the official during the period of officiating.

VII. The promotion is also subject to condition that he/she will have no claim for regular promotion as JTO and seniority in the JTO cadre on the basis of having officiated as JTO. SSA heads may issue officiating orders only after taking a declaration in the format furnished below.

VIII. The pay of the TTAs who are promoted as JTOs on officiating basis may be fixed in accordance with the F.R 35.


IX. The Officiating promotion should not be issued to those TTAs who have declined /not accepted the earlier officiating promotion issued vide this office order No. HRDII/2-1/April - 2014/ dtd.28-03-2014.

X. Before implementing this orders, the respective SSA / Units Heads may please verify and ensure that there is no adverse entry / below bench mark entry in the ACRs of the concerned TTAs for the past 5 years i.e. from 2009 - 10 to 2013 - 14. Such cases if any, may please be brought to the notice of this Office with out effecting the orders to the concerned TTAs.

XI. The officiating promotion from TTA to JTO is subject to the outcome of various court cases.

Copies of local posting orders issued by the SSA Heads and necessary charge reports along with declaration may be furnished to all concerned and the names of the TTAs who have declined the promotion, may be intimated to this office.
