As per the scheme of EPP every upgradation/promotion to the higher scale either through Time Bound or through post based promotion, two weeks training is mandatory (only once for a give scale) executives are directed to under take the training as applicable.

This promotion order, however, is subject to the final outcome of the SLPs pending in various Hon'ble High courts. In case, the executive (s) reverted/demoted or their seniority is re-fixed as per the out come of pending SLPs/court cases, such executive (s) will not be entitled to hold the promoted post and any pay protection or any other benefit attached thereto.
