(4) The promoted Executives are required to join their promotion assignment immediately, but before 08.11.2014 positively.


In case, the officer concerned failed to join his new promotional assignment within the prescribed time, he should not be allowed to join the post thereafter. In such an event, the promotion order shall become inoperative and the matter shall be reported to this office for further necessary action. Further, no request for the modification of promotion/posting orders shall be entertained after the expiry of 08.11.2014.

(5) The leave, if any requested by the officer, who is under transfer, should not be allowed. If any officer desires leave, he/she can apply for leave to the competent authority only after joining the new posting and the Competent authority will sanction leave, if it is considered justified, in the normal course.

(6) These promotions are subject to final outcome of the SLPs No. 5145/2002 (Om Prakash and Others), 3319/2012 (Mohar Singh and others), 23889/2009 (CA No. 4389/2010-Sohan Lal others) and 18902-CA 8929-8945/2012 (Nandlal Jaiswal & others) filed by BSNL in Hon'ble Supreme court.
