History of the case:

The Appellant, Sri. Ashok Kumar, Bangalore had sought certain information vide his RTI application dt. 31.07.2015 and the CPIO had furnished the information in full vide letter dated 01.09.2015. Now the Appellant has preferred First Appeal vide his letter dated 26.04.2016. It is, however, pointed out that the Appellant has not filed the Appeal within 30 days as stipulated under Section 19(1) of the RTI Act.

Contention of the Appellant:

In the appeal the Appellant has stated as follows:-

1. Kindly update as per attached letter and provide the reason for delay.
2. After lot of persuasion with concerned department (PGM HR & Admin, Karnataka) this issue has not been resolved.

Observations of CPIO

The CPIO has stated that the application dt 31.07.2015 was received on 03.08.2015 and the information was furnished on 01.09.2015 which is within the stipulated time as prescribed in the RTI Act. The Appellant was required to appeal against the decision of the CPIO within 30 days (thirty days) from the date of receipt of the information as per Clause 19(1) of RTI Act 2005 which has not been adhered to by the Appellant and therefore the appeal may not be admitted. Further the CPIO has stated that the information furnished vide his letter dated 01.09.2015 holds good. The CPIO has also stated that the Appellant in his Appeal has raised fresh issues rather than appealing against the information supplied in respect of his RTI Application dt 31.07.2015. In spite of these, the issues raised by the appellant has been got examined by the CPIO and the concerned unit in this office has intimated that BBN is requested to pay the Security Deposit and raise ATD to Circle Office.

DECISION

In the light of the above discussions and findings, the undersigned, being the First Appellate Authority for the above Public Authority, is of the view that the information furnished by the CPIO to the Appellant in response to his RTI application dated 31.07.2015 is in order. Though the Appeal is time barred, the issues raised in the Appeal has been got examined by the CPIO. Hence, the CPIO is hereby directed to provide further information as available with him with regard to his RTI Application dated 31.07.2015 as stated above, within 10 days of receipt of a copy of this letter.

The Appeal is accordingly disposed of.
