3. As far as Group 'C' & 'D' is concerned, there is one case reported to this office which is of Shri A.N. Koli, Sr. TOA(G), Belgaum who surrendered the Caste Certificate to the Tahsildar, Chikodi on "Koli Caste" being declassified as ST Community on the strength of which he originally secured employment in the erstwhile DOT. There is no instance of any candidate securing employment on the basis of bogus SC/ST certificate reported after 11.03.2002. However the applicant may seek all such information from CPIOs of SSAs since there might be instance which are not reported to Circle Office.
