- 2.A copy of the mark list available in this office, duly certified, which contain marks obtained by the 4 PH candidates will be furnished on payment of additional fees. (4 A3 pages). HPC not conducted for declaring PH result.
- 3.Part of No.2, 3 and 15 regarding yearwise vacancies for the year 1997 to 2001, break up for JTO vacancies as available as on 31.3.2000 to 31.3.2002 under 15% Q & 35% Q is furnished below. JTO vacancy details prior to the above mentioned period is not available in this office. JTO vacancies are calculated as per the guidelines issued by BSNL Corporate office from time to time.

Appropriate reply was given to the candidates after scrutinizing/compiling the applications. Subsequently 38 applications (in the month of November 2015) were received which were scrutinised and recorded after approval from the competent authority. No reply was given to the candidates. There was also a representation from NFTE and appropriate reply was given to that letter. Again 18 representations were received from candidates. The matter was also referred to BSNL CO for guidelines and reply has been received from BSNL CO. Copy of the above said representations, replies given, letter referring the case to BSNL CO and their reply which contain the information sought by the applicant be furnished on payment of additional fee. Total pages are 112 approximately.
- 11. There are no guidelines in the matter available in the concerned file.
- 12. The information sought in not available.
- 13.No result was declared in 2008 by applying relaxation standard as per BSNL CO letter dated 10.3.2003.
- 14. Various decisions on various matters are taken at various levels depending upon the level of competent authority at which such decision are to be taken as per existing guidelines/orders. Exam related work/action is vast and spanning, some times, even over a number of years.
