History of the case:

The Appellant, Sri. Nishchal C V, Bangalore had sought information vide his RTI application dt.31.07.2015 regarding refund of Security Deposit amount of Rs.5000/-, deposited at the time of JTO Recruitment. The information sought by the applicant was furnished by CPIO in full vide letter dated 31.08.2015.

Contention of the Appellant:

Now the Appellant in his Appeal dt.09.09.2015 has stated that he is not satisfied with the reply of CPIO. According to appellant the information furnished against his RTI case dt. 31.07.2015, is incomplete, misleading or false information.

Observations of CPIO

CPIO has refuted the contentions of the Appellant and stated that the information in respect of his application dt. 31.07.2015 have been furnished fully vide his letter dt. 31.08.2015. In fact, the appeal is improper for the reason that the Appellant has raised a fresh query out of the information furnished by CPIO vide letter dated 31.08.2015, whereas he should have sought fresh information sought in the Appeal through a fresh RTI application.

However, the appeal has been processed in consultation with the unit concerned in this office which has stated that Security Deposit for Rs.5000/- has been transferred to present unit i.e. BBNW Bangalore through the document number 1000126000 dt. 30.09.2015 raised in ERP and further the payment will be processed by the unit in which the employee presently working.


