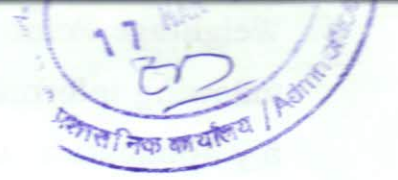

Herein I Shri. And while on duty my father was passed away on 21.07.2002. Thereafter your department had issued letter to my mother Smt. Rizwan W/o Late Farukhahmed Madiwale to apply for the appointment under compassionate ground, but my mother replied by requested that to give the appointment to me as I am elder son and when I became major.

Subsequently I applied for appointment under compassionate ground, for which your department asked several documents to do the needful. As per your requirement I submitted all the documents before you. But thereafter I waited several months for your reply but there is no any reply from your department. Therefore I personally meet your office and asked about my appointment but in response you have stated that my application was rejected and you have issued the copy of rejected letter to me. On going through the letter my application was rejected as I am not eligible for appointment under compensation ground under Weightage point system.

On going through the said rejected letter No. Q-806/CA/15 dated 17-01-2014, I did not found how much I got the points under

Weightage Point System. Hence I request you to kindly furnish to me following information in respect of points which are granted to me on my application. under Right to Information Act.

- 1) How much net point i got under Weightage Point System?
- 2) How much and under which factor the points has been granted?
- 3) In totally what are the factors taken into consideration under Weightage Point System?
- 4) Furnish me a copy of corporate office letter No. 273-18/2005-pers.IV dated 27-06-2007.
- 5) The copy under what circumstances & which factor how much points will be considered?
