Sub : Additional Information requested under RTI Act 2005..

Ref: 1. My letter dated 02.07.2015 requesting information Under RTI regarding Preponement of Promotion of Sri. T.R. Gundappa, (Rtd AGM (Staff), O/o. CGM (T), Karnataka Circle, Bangalore - 560 008) from JTO to TES Group 'B' Cadre.

2. Your letter No. RTI/2015-16/C-20/5 dated 20.07.2015.

Kindly refer to the letters cited under reference 1 & 2 above. I have gone through your office letter cited under reference 2 and the judgement of the Hon'ble High Court of Karnataka dated 24.11.2004 on the above case. I request you to kindly supply me the following additional information under RTI act 2005.

1. As per para 4 of the Hon'ble High Court Judgement, the Petitioners should give effect to the final seniority list produced at Annexure 2 by giving the promotional benefits notionally and also fix the pensionary benefit to them according to law within 4 weeks from the date of receipt of the order. Please provide me a copy of the final seniority list referred above and also inform me what law / rule is applied to promote the officers from JTO to TES Group 'B' in this case (stepping up of promotion / pay / pension at par with their Junior Sri. KSS Bhavachari or Rule 206 of P&T Manual Vol. IV or any other rule).

2. Sri. T.R. Gundappa was extended the actual benefit from 28.10.1981 as per the implementation order issued by CGMT Karnataka Circle Bangalore letter No. Staff/24-109/2005 dt. 27.08.2005, i.e. his date of assumption of charge as AE in TES Group 'B' which is 28.10.1981. Please inform whether the officer has assumed charge as AE in TES Group 'B' on regular basis from 28.10.1981 as per promotion order issued by TCHQ or on local officiating arrangement. If it is as per TCHQ order of promotion to TES Group 'B' please provide a copy of the order. If it is on local officiating arrangement please confirm whether the officer was officiating on local officiating arrangement from 28.10.1981 to 31.01.1986 when regular promotion order was issued earlier by TCHQ and his regular service is counted from 28.10.1981 for effecting the Senior SDE promotion from 28.10.1993 (after completing 12 years service) or it is as par with his Junior Sri. K.S.S. Bhavachari.

3. As per D.O.T letter No. 15-54/97-STG II dt. 11.08.2005 (implementation of Hon'ble High Court of Karnataka Judgement) it is stated that the implementation of the Hon'ble High Court of Karnataka order dated 24.11.2004 is subject to the outcome of the SLP pending in the Hon'ble Supreme Court of India in this regard. Please inform whether the judgement is delivered by the Hon'ble Supreme Court of India in this case and if delivered already please inform whether the SLP is upheld or dismissed by the Hon'ble Supreme Court of India (copy of the Hon'ble Supreme Court of India order may be given).

The necessary fee for providing the information sought above is enclosed in the form of postal order for Rs.500/- assuming it may be around 50 pages. If the pages exceed I will give whatever additional fee is due when intimated.
