

Sub: Compassionate ground appointment – Clarification regarding.

Sir,

I am directed to refer your office letter No. R&E/2-5/MISC/2003 dated 9.02.2004 seeking clarifications whether to consider the requests of compassionate ground appointment wherein family pension and other benefits are not settled because of appointment of deceased officials after the formation of BSNL on 1.10.2000. It is clarified that whatever terminal benefits have been actually given, the same should be taken into consideration for working out financial indigency. Of course, a balanced and objective assessment of the financial condition of the family has to be made taking into account its assets and liabilities and all other relevant factors such as presence of an earning member, size of family, ages of children and the essential needs of the family etc.

Married daughter's request for compassionate ground appointment cannot be acceded to as she cannot be treated as wholly dependent family member of the ex-official.

This is for your information and necessary action.
