
Sir,

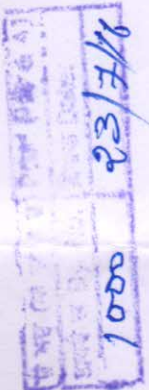
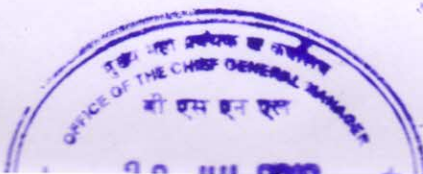
