I kindly request you to provide the following information under RTI Act, 2005 in respect of Canteen of CGM Office, Bangalore. I am enclosing Indian Postal Order (IPO No.30F 070365) for Rs.10 towards application fee, as per the provisions of RTI Act, 2005.

- 1) Whether the rates for the food items sold in the canteen are same for both employees and General Public?
- 2) Provide the rates applicable for employees in respect of the food items sold in the canteen
- 3) Whether the price list to be displayed as per the Tender Agreement? If so, why the Canteen Committee is not ensuring the display of price list?
- 4) Whether the staff in the canteen should wear uniforms and badge as per the Tender Agreement? If so, whether it was adhered to? If not, whether any action was taken by the Canteen Committee?
- 5) What are main conditions to be followed by the successful contractor as per the Tender Agreement?
- 6) Whether the Menu Card is strictly adhered to? If not, whether any penalty is imposed as per the Tender Agreement?


7) Whether any surprise checks has been made by the Canteen Committee to ensure the tender conditions? If so, what were the observations made by the Canteen Committee?
