Please refer to your above-mentioned RTI application seeking information under RTI Act 2005. In this regard, the pointwise available information as received from the concerned unit is furnished herewith.

Point No.1: 102 candidates have successfully completed document Verification process, out of 120 candidates declared successful in Karnataka cirlce.

Point No.2. & 3: Appointment letter has not been issued to anybody so far.

Point No.4: The minimum qualifying marks for each of the three parts of the question paper are 30% for candidates belonging to OC Category and 20% for candidates belonging to SC/ST/OBC Category. Further the minimum qualifying marks in aggregate are 40% for candidates belonging to OC Category and 33% for candidates belonging to SC/ST/OBC Category. Candidates obtaining less than minimum qualifying marks in any of the three parts as well as in aggregate are not considered for inclusion in the merit list. No other cut off marks is fixed for the said examination.
