In this regard the concerned unit in this office has intimated that the Sub Rule 37A(11A) of CCS(Pension) Amendment Rules, 2002 provides for absorbed BSNL employees having a minimum 10 years of composite qualifying service rendered in DoT and BSNL are eligible to opt for voluntary retirement.: As per rules, three months is prescribed for voluntary retirement: however the same can be relaxed by the appointing authority depending on the circumstances. A copy of Memorandum No. 31-94/2004-Pen/BSNL dated 8.10.2014 circulated by BSNL Corporate Office in regard to amendment to CCS(Pension) Rules, 1972 is enclosed herewith for reference and information please .
