## **SECTION II INSTRUCTIONS TO BIDDERS**

### SERVICES TO BE PROVIDED

1. Services to be provided are given in Section VI.
2. ELIGIBLE BIDDERS:
  - (a) The bidder should own or on lease sufficient number of vehicles of model not older than 2006 year which are registered as commercial vehicles in their names or Firm's name. The proof of ownership or lease holding should be produced as and when called for.
  - (b) The bidder shall also submit full details of the vehicles that can be assigned in their favour and shall give a clear declaration that the firm will be able to supply commercial vehicle of model not older than 2006 (Year)
  - (c) Preference will be given to the bidder who shall have experience of minimum period of one year for similar type of contract of supplying commercial vehicles to any Govt. organization or any Public Sector Undertaking, when all other condition remain the same.
  - (d) Bidders with white board vehicle may also apply for tender. In such case he has to give a undertaking that, he will obtain taxi permit (convert to Yellow board) within a fortnight.

### 3. COST OF BIDDING:

The bidder shall bear all costs associated with the preparation and submission of the bid. BSNL in no case be responsible for these costs regardless of the conduct or outcome of the bidding process.

3.1 Estimated cost of the Tendered value for each vehicle is Rs.3,00,000/ approximately per year.

### 4. BID DOCUMENT :

4.2 The bidder is requested to examine all instructions, forms, terms and specifications in the Bid Document. Failure to furnish all the information required as per Bid Documents or submission of the bids not substantially responsive to the Bid Documents in every respect will be at the bidder's risk and may result in rejection of the Bid.

6. AMENDMENT TO BID DOCUMENT:

- i) At any time, prior to the date of submission of bid, BSNL may, for any reason whether at its own initiative or in response to a clarification required by a prospective bidder, modify the Bid Documents by amendments.
- ii) The amendments shall be notified in writing to all prospective bidders and these amendments will be binding on them.

7. DOCUMENTS COMPRISING THE BID:

The bid prepared by the bidder shall comprise the following components.

- a. Documentary evidence established in accordance with clause 2 that the bidder is eligible to bid and is qualified to perform the contract if his bid is accepted.
- b. Bid security furnished in accordance with clause 11.
- c. A clause by clause compliance as per clause 10.
- d. Bid form and price schedule completed in accordance with clause 8 and 9.

8. BID FORM:

The bidder shall complete the Financial bid form as per Section V of the bid document and Technical Bid Form as per Section VII A.

9. BID PRICE:

- i) The price quoted by the bidder shall remain fixed during entire period of contract and shall not be subject to variation on any account. A BID submitted with an adjustable price quotation will be treated as non-responsive and rejected.
- ii) “Discount” or extra charges if any mentioned by the bidders shall not be considered unless these are specifically indicated in the price schedule.

10. CLAUSE BY CLAUSE COMPLIANCE:

A clause by – clause compliance of service to be provided (SECTION VI), and special condition (Section IV) shall be given. In case of deviation a statement of deviation shall be given.

11. BID SECURITY / EMD:

- 11.1 Pursuant to clause 7, the bidder must deposit Rs.7500/-(Rupees Seven Thousand Five hundred Only) as Bid Security. The Bid Security shall be in the form of DD valid for 180 days from the date of tender opening may be submitted in Technical bid cover. Successful bidders EMD will be retained as security deposit.
- 11.2 The tenderer can opt other places at the minimum rates if his tender is not accepted at the station applied.
- 11.3 THE BID SECURITY MAY BE FORFEITED : The bid security will be forfeited.
- A) If bidder withdraws his bid during the period of bid validity specified by the bidder in the bid form.
- B) If the successful bidder fails.
- i) To sign contract in accordance with clause 18
- ii) To furnish performance security in accordance with clause 2 of Section III.
- iii) A bid not secured in accordance with para 11.1 shall be rejected by the BSNL as non-responsive at the bid opening state and returned to the bidder unopened.
- 11.4 The bid security of unsuccessful bidder will be discharged/returned as early as possible but not later than 30 days after the expiry of the period of bid validity.
12. Format and signing of bid: The bidder shall prepare one complete set of originals of Technical bid and Financial bid placed in separate covers clearly making them as Technical bid and Financial bid. In the event of any discrepancy, the original shall govern.
- 12.1 The original and copies of the bid shall be typed or printed and all pages numbered consecutively and shall be signed by the bidder or a person duly authorised to bind the bidder the contract.
- 12.2 The over writing / erasures in the bid made by the bidder shall be signed by the person signing the bid.
- 12.3. The letter of authorization shall be indicated by written power-of-attorney accompanying the bid. All pages of the original bid, except for un-amended printed literatures shall be signed by the person or persons signing the bid. The bids submitted shall be sealed properly.
- 12.4. (i) The power of Attorney should be submitted and executed on the non- judicial stamp paper of appropriate value as prevailing in the respective states(s) and the same be attested by a Notary public or registered before Sub-Registrar of the states(s) concerned.
- (ii) The power of Attorney be executed by a person who has been authorized by the Board of Directors of the bidder in this regard, on behalf of the Company/Institution /Body corporate.
- (iii) In case of the bidder being a firm, the said power of Attorney should be executed by all the partner(s) in favour of the said Attorney.

13. SUBMISSION OF BID: THE COVER CONTAINING THE BIDS SHOULD BE SEALED WITH WAX.

The bids should be submitted in two covers. The first cover super scribed as "Technical Bid" shall contain documents establishing bidders eligibility as per clause 2& 5 of Section –II and a certificate on relatives working in BSNL as per clause –8 of section –IV. The second cover super scribed as "financial bid" shall contain only the rates quoted by the contractor for each item shown in the schedule of requirement as per Section –V. The original copy of the technical bid is to be produced when called for before acceptance. Both the cover to be put in single cover super scribed as `` TENDER FOR HIRING OF MULTI UTILITY VEHICLE''.

14. BID OPENING:

BSNL shall open bids in the presence of bidders or their authorised representative who wish to be present at the time of opening of bids on due date. Authorization letter to this effect shall be submitted by the bidder before they are allowed to participate in bid opening (Format is given in Section X). Technical Bid will be opened first. If the contractor is eligible to participate, then his Financial Bid will be opened.

(i) The bid should be submitted duly sealed and addressed to Sri. A.V.Anvekar, AGM(Admn), O/o GM Telecom, Uttar Kannada Telecom Dist, Karwar and delivered in person on or before 15:00 hrs. of 5-10-2009.

(ii) Any bid received after the dead line for any cause for submission of bids shall be rejected and returned to the bidder.

14 BID OPENING

BSNL shall open the technical bid cover containing documents detailed as per section VII – A in the presence of bidders or their authorized representative who wish to be present at the time of opening of bids on due date. Authorization letter to this effect shall be submitted by the bidder before they are allowed to participate in bid opening(format is given in Section –X). The financial bid will be opened only in those cases who fulfill the eligibility condition and furnish all documents as given in technical bid.

15 VALUATION :

15.1 BSNL shall evaluate the bids to determine whether they are complete, whether any computational errors have been made whether documents have been properly signed and whether bids are generally in order.

15.2 If there is a discrepancy between words and figures the amount in words shall prevail prior to detailed evaluation, BSNL will determine the substantial responsiveness of each bid to the bid document. A substantially responsive bid is one, which confirms to all the terms and conditions of bid documents without material deviation. A bid determined as substantially non-responsive will be rejected by BSNL.

15.3 BSNL shall evaluate in detail and compare the substantially responsive bids and comparison of bids shall be on the price of the services offered inclusive of all levies and charges as indicated in the price schedule in Section V of the bid document.

15.4 Tender shall be evaluated by an evaluation committee setup by G. M. Telecom, Karwar. The evaluation committee will recommend the lowest rates taking into consideration of prevailing market rates, for the place/ SDCA for which vehicle is offered and valid documents.

16 AWARD OF CONTRACT:

BSNL shall consider placement of letter of intent to those bidders whose offers have been found technically, commercially and financially acceptable. The bidder shall within 2 weeks of issue of letter of intent, give his acceptance along with performance security in conformity with Section IX with the bid document.

17 RIGHT OF VARY QUANTITIES:

BSNL reserves the right at the time of award of contract to increase or decrease upto 25% of the required quantity of services specified in the schedule of requirements without any change in hiring charges of the offered quantity of other terms and conditions.

18 SIGNING OF CONTRACT:

18.2 Signing of Agreement shall constitute the award of hiring contract on the bidder.

18.3 Upon the successful bidder furnishing the Performance Security the BSNL shall discharge its bid security in pursuant to clause 11.

19 ANNULMENT OF AWARD:

Failure of the successful bidder to comply with the requirement of clause 18 shall constitute sufficient ground for the annulment of the award and forfeiture of the bid security in which event BSNL may make the award to any other bidder at the discretion of BSNL or call for new bids.

20 PERIOD OF VALIDITY OF BIDS:

- (i) The bid shall remain valid for 180 days after the date of opening of bids. A bid valid for a shorter period shall be rejected by BSNL as non-responsive.
- (ii) A bidder accepting the request of BSNL for an extension to the period of bid validity, in exceptional circumstances, will not be permitted to modify his bid.

**SECTION III  
GENERAL (COMMERCIAL) CONDITIONS OF CONTRACT**

1. APPLICATION :

Submission of bid against this offer shall bind the bidder for the acceptance of all the conditions specified herein or in NIT unless otherwise agreed by BSNL.

2. PERFORMANCE SECURITY:

- 2.1 For successful bidders the Bid security will be converted into performance security. In addition, the successful bidder shall be required to deposit an amount equal to 7.5 % of the tendered value i.e. Rs. 22500/- subject to maximum limit of Rs.5 lakhs within two weeks of conveying BSNL's intention for accepting the bid as Performance Security.
- 2.2 Performance Security shall be submitted in the form of DD/Bank Guarantee issued by a scheduled Bank and the Performance provided in Section IX of the Bid Document.
- 2.3 Performance Security will be discharged after completion of contractor's performance obligations under the contract.
- 2.4 If the contractor fails or neglects any of his obligations under the contract it shall be lawful for BSNL to forfeit either whole or any part of performance security furnished by the bidder as compensation for any loss resulting from such failure.

3. EXECUTION TIME LIMIT:

- 3.1 The time period as stipulated in the contract or letter of intent shall be deemed to be essence of the contract.

4. PAYMENTS TERMS:

Monthly bills shall be submitted in duplicate to the authority specified in contract along with completed duty slips duly signed by the user. The copy of service tax paid challan for the previous month /quarter as the case may be should be produce along with the bills for payment.

4 (a) Prices: -

- (i) Rates charged by the contractor for the services given under the contract shall not be higher than the rates quoted by the contractor in his bid.
- (ii) In case of any reduction of taxes and statutory levies (if any) during the contractual period, BSNL shall take the benefit of decrease in such taxes/duties for the services to be availed from the date of enactment of revised duties /taxes.

- 4 (b) Payment of the monthly bills will be made through NEFT ( National Electronic Funds Transfer). The successful bidders shall have to enroll themselves in the above payment system as per the procedure.

5. TERMINATION OF CONTRACT:

- 5.1 BSNL may without prejudice to any other remedy for breach of contract may terminate the contract in whole or in parts.

(a) If the contractor fails to arrange the supply of any or all of the vehicles within the period (s) specified in the contract or any extension thereof granted by BSNL.

(b) If the contractor fails to perform any other obligation(s) under General & Special conditions of the contract.

- 5.2 BSNL may without prejudice, to other rights under law or the contract provided get the hiring of vehicles done at the risk and cost of the contractor, in above circumstances.

6. TERMINATION FOR INSOLVENCY:

BSNL may also by giving written notice and without compensation to the contractor terminate the contract if the contractor becomes unwilling, bankrupt or otherwise insolvent without affecting its right of action or remedy as hirer.

7. FORCE MAJEURE:

- 7.1 If any time, during the continuance of this contract, the performance in whole or in part by either party of any obligation under this contract is prevented or delayed by reason of any war, or hostility, acts of the public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics, quarantine restrictions, strikes, lockouts or act of God (Hereinafter referred to as events) provided notice of happenings, of any such eventuality is given by either party to the other within 21 days from the date of occurrence thereof, neither party shall be reason of such events be entitled to terminate this contract nor shall either party have any claim for damages against the other in respect of such performance or delay in performance under the contract shall be resumed as soon as practicable after such an event may come to an end or cease to exit, and the decision of BSNL as to whether the supplies have been so resumed or not shall be final and conclusive, provided further that if the performance in whole or part of any obligation under this contract is prevented or delayed by reason of any such event for a period exceeding 60 days either party may, at his option terminate the contract.

8. ARBITRATION :

- 8.1 In the event of any question, dispute or difference arising under the agreement or in connection there with except as to matter the decision to which is specifically provided under this agreement, the same shall be referred to sole arbitration of GMT BSNL, UKTD Karwar or any other person appointed by him. In case his designation is changed or his office is abolished then in such case to the sole arbitration of the officer for the time being entrusted whether in addition to the function of the GMT or by whatever designation such officers may be called (Hereinafter referred to as the said officer). In the event of such Arbitrator to whom the matter is originally referred to vacates his office on resignation or other wise or refuse to do work or neglecting his work or being unable to act as Arbitrator for any reasons whatsoever, the GMT BSNL, UKTD, Karwar shall appoint another person to act as an arbitrator in the place of outgoing Arbitrator and the person so appointed shall be entitled to proceed further with the reference from the stage at which it was left by the predecessor and that the award of the arbitrator shall be final and binding on both the parties. Contractor will have no objection in any such appointment that arbitrator so appointed is an employee of BSNL or a Government servant or that he has to deal with the matter to which the agreement relates or that in the course of his duties as a BSNL employee he has expressed his views on all or any of the matters in dispute. The adjudication of such Arbitrator shall be governed by the provisions of the Arbitrator and Conciliation Act 1996, or any statutory or re-enactment of or any rules made thereof.

- 8.2 The venue of the arbitration proceedings shall be office of GM Uttar Kannada Telecom District , BSNL, Karwar or such other place as the arbitrator may decide.
- 8.3 The Arbitrator may from time to time with the consent of both the parties enlarge the time frame for making and publishing the award. Subject to aforesaid arbitration and conciliation Act 1996 and the rules made there under, any modification thereof for the time being in force shall be deemed to apply to the arbitration proceeding under this clause.
9. SET OFF:  
Any sum of money due and payable to the contractor (including security deposit refundable to him) under this contract may be appropriate by BSNL and set off the same against any claim of BSNL for payment of a sum of money arising out of this contract or under any other contract made by contractor with BSNL.

**SECTION IV  
SPECIAL CONDITIONS OF CONTRACT**

1. The special conditions of contract shall supplement the instruction to the Bidders as contained in Section II and General (Commercial) conditions of the contract as contained in Section III and wherever there is a conflict, the provisions herein shall prevail over those in Section II and Section III.
2. In case the date fixed for opening of bids is subsequently declared as holiday by the Government of India, the revised schedule will be notified. However, in absence of such notification, the bids will be opened on next working day, time and venue remaining unaltered.
3. BSNL reserves the right to disqualify such bidders who have a record of not meeting contractual obligations against earlier contract entered into with BSNL.
4. BSNL reserves the right to blacklist a bidder for a suitable period in case he fails to honour his bid without sufficient ground.
5. The liability under relevant Sections of Motor Vehicle Act 1968 and IPC causing death or permanent liability developed in the vehicle supplied by the contractor, the hiring authority has no responsibility of whatsoever and will not entertain any claim in this regard under the provision of the law.
6. The engagement and employment of drivers and payment of wages to them as per existing provisions of various labour laws and regulation is the sole responsibility of the contractor and any breach of such laws or regulations shall be deemed to be breach of this contract.
7. No, sub-contracting is permissible by BSNL. The near relatives of all BSNL employees, executive/Non-executive employees either directly recruited or on deputation are prohibited from participation in this tender. The near relatives for this purpose are defined as :
  - (a) Members of a Hindu Undivided Family,
  - (b) They are husband and wife,
  - (c) The one is related to the other in the manner as father, mother son(s), son's wife (daughter-in-law), Daughter(s) & daughter's husband (son-in-law), brother(s) & brother's wife, sister(s) & sister's husband (brother-in-law).
8. The tenderer(s) should give a certificate to the effect that none of his/her such relative is working in the units of BSNL as defined above. In case of proprietorship firm the certificate will be given by the proprietor, for partnership firm certificate will be given by all the partners and in case of Limited Company by all Directors of the Company. Any breach of these conditions by the company or firm or any other person, the tender/work will be cancelled and earnest money/security deposit will be forfeited at any stage whenever it is noticed. The BSNL will be pay any damages to the company or firm or concerned person. The company or firm or the person will also be debarred for further participation in the concerned unit.

9. The contractor shall assign the job of driving of hired vehicles only to qualified experienced licensed drivers and also assume full responsibility for the safety and security of the officers/officials as well as essential store items while running the vehicle by ensuring safe driving. The attested copy of driving license of all such drivers should be submitted during the contractual period. BSNL shall have no direct or indirect liability arising out of such negligent, rash and impetuous driving which is an offence under Section 29 of IPC and any loss caused to BSNL or other wise have to be suitably compensated by contractor.
10. The contractor shall when called upon to do so, place at the disposal of BSNL such number of vehicles as may be required although the number of vehicles so demanded may be more than the number of vehicles he is required to supply for the purpose of execution of the contract at the same rate and terms and conditions. The number of such vehicles to be supplied extra will not be more than 25% of original schedule or requirement in the NIT.
11. In no case a vehicle which is not registered for the commercial purpose shall be supplied to BSNL and taxes, insurance's, Road tax etc. due on such vehicles shall be liability of the contractor. The attested copy of R/C. Book and the insurance policy of vehicles supplied under this contract should be submitted to the authorized person of the BSNL and will be subject to scrutiny.
12. The contractor shall send the vehicle for periodical servicing at the cost of the contractor, BSNL will not pay any mileage run for such servicing nor any deduction be made for the duration involved in such servicing. The cost of lubricants, repairs, maintenance, taxes insurance, etc. will be the contractor's liability.
13. BSNL reserves right to counter offer price against price quoted by the bidder.
