**TENDER NOTICE**

On behalf of the Bharat Sanchar Nigam Limited, sealed tenders are invited by the General Manager Telecom District Gulbarga from the Licensed Manufacturers / Experienced Registered Contractors who have done repairs works of all types & capacity SMPS Power Plants of Telephone Exchanges. The Tender is for “REPAIR OF POWER PLANTS” of various makes, Capacity & at DRC Gulbarga.

**TERMS AND CONDITIONS**

**GENERAL**

The tender forms will be issued on production of 1) attested clear Photostat copy of the certificate of Registration of firm for Manufacturing of SMPS Power plants. 2) Experience certificate with registration copy, on payment of Rs.563/- (Rupees Five hundred sixty three Only.) (including Tax) per copy at the cash counter of O/o GMTD, BSNL, Gulbarga on all working days between 22<sup>nd</sup> Apr 2009 up to 07-05-2009, 12:30 Hrs. Tender document can also be downloaded from website [www.karnataka.bsnl.co.in](http://www.karnataka.bsnl.co.in). Those who wish for applying through downloaded copy should use original print ( Xerox copy not allowed) and also enclose additional DD for Rs 563/- towards cost of tender document.

1. Sealed tenders superscribed as “ TENDER FOR REPAIR OF POWER PLANT MODULES IN GULBARGA SSA” should be addressed to Shri. M K Vagger, Assistant General Manager(Plg) O/o GMTD, BSNL, Near HPO Gulbarga-585101 and may be dropped in the Tender Box kept in the Chamber of AGM (Plg), o/o the GMTD Gulbarga on or before 1500 Hrs of 7<sup>th</sup> may 2009. The Technical bid and Financial bid are to be kept in separate envelopes and are to be put together in the main envelope. The Technical Bid will be opened on the same day at 15:30 hours in the presence of those tenderers who wish to be present or their representatives, first Technical bid will be opened. The successful technical bidders financial bid will be opened after verification of genuineness of Technical bid on 07-05- 2009.
2. The tenderer should enclose the following documents along with the tender schedule as **Technical bid**. The
  - (a) attested clear Photostat copy of the certificate of Registration of firm for Manufacturing of Power Plants/ repair experience Certificate.
  - (b) Experience Certificate for Maintenance / repair of Power Plants from the Head of Units / of the rank of Class-I Officer on their respective letter heads.
  - (c) A minimum of 2 (Two) years experience certificate (Issued by not below the rank of JAG Officer) of having repaired / main-tained the SMPS types PPs for BSNL or any similar organization.

- (d) Infrastructure assessment of the tenderer : To ascertain the infrastructure availability which will include skilled man power resources, measurement/instrumentation facility, testing facility, component procurement method and availability of suitable premises for storing/repair of faulty SMPS units, has to be declared in separate sheet signed by the tenderer. If necessary the genuineness of declaration will be verified.
3. The tenderers which do not furnish correct and complete information and / or not accompanied by EMD are liable for rejection.
  4. The tenderer should quote the rates in **Annexure-II** enclosed herewith. Which should be inclusive of materials, transportation, labour and all Taxes etc.
  5. The successful tenderer should attend to any fault on Power Plants / its modules etc of any make/ capacity as & when reported by the Sub-Divisional Engineer DRC Gulbarga. within one day of reporting the trouble.No extra payment will be made for the visit for clearing the fault when reported by the SDE DRC.
  6. The successful tenderer should:-
    - (a) Enter into an agreement with BSNL within Fifteen days from the date of acceptance of the tender on a non judicial stamp paper of Rs.100/-
    - (b) Produce the certificate of registration with the Assistant Commissioner of Labour(central), Bellary within one month from the date of award of the tender, if he employs more than 20 (Twenty) labourers for the work mentioned in the tender, otherwise he should give a declaration regarding the number of labourers employed by him if he has not employed more than 20(Twenty) labourers
  7. Tools, measuring instruments or any other equipment needed for repairs / maintenance of Power Plants shall be arranged by the contractor.
  8. Faulty Power Plant should be attended at DRC Gulbarga within 24 Hrs from the date of reporting by the SDE DRC and after satisfactory repairs, the Contractor has to submit the service report with brief details of repairs carried out and the details of components replaced. And after repair the contractor should ensure that the Power Plant & its Modules are working Satisfactorily. The contractor should return the faulty items which are rendered spare after replacing by new one to the concerned SDE DRC along with a list of the same.
  9. Before closing of contract all Power Plants & its modules should be in good working Condition and to be shown to the SDE DRC /SDE concerned. If any fault should be made good within contract period, if he fails to attend as above, BSNL will attend

- the repair work at the cost of Contractor at his risk.
- 10 The Spares and other replacements should be original and of same quality/rating/material that was used in the original SMPS PP.
  - 11 Routine service including cleaning etc should be done at the time of repair. Service report duly signed by the SDE DRC to enclosed to the bill.
  - 12 The bill may be claimed by the Contractor after completion of each work order, enclosing certificate of satisfactory working of SMPS PP.
  - 13 Any attempt for negotiations or bringing influence by any means for the acceptance of the tender will render the tender liable for exclusion from consideration.
  - 14 The contractor should intimate the name of the persons who are working under him in any capacity or subsequently employed by him.
  - 15 The contractor shall observe all the rules regarding wages to the labours, protection of life, health and sanitary arrangements of the workers employed by him and pay the required compensation to the workers payable under the workmen Compensation Act : 1923 For injuries or disabilities or death caused in the process of execution of the work. The tenderer / contractor shall engage his labour in accordance with the Labour Act in force.
  16. The contractor shall observe all labour regulations while employing his labourers. No labourer below the age of 18(eighteen) years shall be employed for the works. In every case in which by virtue of provisions in the section 12 sub-section (1) Of the workmen Compensation Act 1923, where Government is obliged to pay compensation to a workman employed by the contractor for execution of the work, the Government will recover the amount of compensation so paid from the contractor by deducting from the Security deposit or from any sum due from Government to the contractor whether under this contract or otherwise. In such cases, the decision of the Labour Commissioner of the locality will be final and binding.
  17. The contractor shall not charge any extra amount for traveling/ overtime allowances and charges for materials used by him and will not be entitled to get compensation for any damage or loss in the course of execution of the work during the period of tender.
  18. The contractor shall not assign or sublet the contract or any part thereof. The Contractor shall not assign the work either directly or indirectly to any of the staff Working in BSNL.
  19. The security deposit along with EMD furnished by him will be forfeited to BSNL without prejudice to any other rights of the Government under the following circumstances:

- (a) In the event of the contractor failing to observe or perform any of the conditions of the work as set out in this Tender.
  - (b) In the case of Unsatisfactory work done by the contractor.
  - (c) In the event of not complying with the orders/instructions issued by the BSNL or with the terms and conditions of this tender notification.
  - (d) In the event of not completing the formalities mentioned at Clause no. 6 above.
20. In case of any matter/dispute arising out of this contract, the matter will be referred to the sole arbitration of the General Manager Telecom District Gulbarga or any other person nominated by him, whose decision will be Final and binding.
21. The General Manager Telecom Gulbarga is not bounded to accept the lowest tender.
22. The General Manager Telecom Gulbarga may cancel one or all the tenderers without assigning any reasons.
23. The General Manager Telecom District Gulbarga may terminate this agreement at his option any time by giving 14 (Fourteen) days notice and without assigning any reasons.
24. In case of non standard or bad work, the GMTD Gulbarga may recover the cost of such work from the SD or from amount due to the Contractor. In case the SD/Amount due to the contractor is less than the cost of the non standard/bad works, the contractor must make good at his own cost of such amount within stipulated time.
25. In the event of any damages sustained by the Department due to unsatisfactory execution or delay in carrying out the work by the approved contractor, the General Manager Telecom District Gulbarga may forfeit the EMD/SD and also recover the cost of the damages . In assessing the cost of the damages, the decision of the General Manager Telecom District Gulbarga shall be final. The General Manager telecom District Gulbarga reserves the right to forfeit the entire Security Deposit for improper works carried out by the contractor.
26. L1 will be decided based on the total amount of rates quoted in Part II of **Annexure II** (Bid Document). The rates quoted in Part I of **Annexure II** will be negotiable with the Lowest rates quoted by the tenderer for Part II of **Annexure II**. BSNL reserves the right to award the bids separately or together.
27. The General Manager Telecom District Gulbarga reserves the right to : (i) Award the contract to one or more contractors as he may think fit. (ii) Get the work done departmentally.
28. **WORK SPECIFICATION** : The Contractor should supply the required men & spares for repair of all types/capacity of SMPS power plants & its modules and will have to do repair during the

contract period out of the list of Power Plant modules, make wise and capacity wise available at ANNEXURE - I. The repair should be carried out at DRC Gulbarga, made available by BSNL. The number of PP modules to be repaired aprox----

- a) 100 Amp -----45 Nos
- b) 25 Amps -----180 Nos

The quantity for repair may vary by 20%

The repair work should be neat, clean and fault free and to the satisfaction of the Officer in charge.

### **29. EMD**

- (a) Each tender should be accompanied by an EMD of Rs.16500/- (Rupees Sixteen Thousand five hundred only) in the form of crossed Demand Draft, drawn in favour of the Accounts Officer( cash), O/o GMTD, BSNL, Gulbarga.
- (b) The EMD of the unsuccessful tenderer will be refunded after finalization of the Tender.
- (c) The EMD of the successful tenderer will be converted as Security Deposit . The EMD/SD while in custody of GMTD M/S BSNL Gulbarga will not carry any interest.
- (d) The EMD of the successful tenderer will be forfeited to BSNL if the successful tenderer fails to complete all the formalities within the specified time.

**30. SECURITY DEPOSIT :** The successful tenderer should deposit a sum of Rs.16500/- ( Rupees Sixteen Thousand five hundred only). as Security Deposit, within ten days from the intimation, for fulfillment of the contract. This will be in addition to EMD converted into Security Deposit. The same will be refunded after three months from the satisfactory completion of the entire contract. The SD does not carry any interest.

### **31. PAYMENT**

- a) The bills through SDE DRC Gulbarga, in duplicate along with service report addressed to The GMTD Gulbarga should be submitted. The 90% payment will be made by the General Manager Telecom District Gulbarga after the work is done satisfactorily and certified by the SDE DRC, by crossed cheques. Remaining 10% bills will be paid after completion of tender period.

- b) The payment made by GMTD Gulbarga shall be accepted by the contractor by crossed cheque against submission of the bills in duplicate duly stamped pre-receipted to the officer in-charge. But the bills must be addressed to the General Manager Telecom District Gulbarga.
- (c) No advance payment will be made under any circumstances.

**32. BID VALIDITY PERIOD:** 60 days from date of opening of tender.

**33. VALIDITY :**The tender will be valid for one year commencing from the date of acceptance of the tender and signing of the agreement.

**34. PENALTY:** If the faults are not attended within the period specified in Clauses above, penalty of Rs. 50/- per day subject to maximum of Rs. 500/- will be levied. At the time of terminating the tender all the units should be in working condition. This penalty will be deducted from bill amount payable to contractor. This penalty is in addition to the penalties mentioned in the preceding paras of this tender.

**35. REGULATIONS COVERING THE TENDERS**

- a) The contractor shall also intimate the names of the persons who are working under him in any capacity or subsequently employed by him and who are near relative of the officers of Bharat Sanchar Nigam Ltd. Any breach of this condition by the contractors would render him liable to be removed from the Approved list of contractors of BSNL.
- b) Contractors who have near relatives posted as Officers in Karnataka Telecom Circle/Gulbarga Telecom District or in subordinate offices thereto are not permitted to tender against this notice inviting the tender. No one connected with or in the employment of BSNL shall ever be admitted as partner.

Near Relatives include:

- i) Sons, daughters, father, mother, brothers, sisters, grandfather, grandmother, grandsons, grand daughters.
- ii) Uncles, aunts, first cousin, nephew, nieces directly related by blood.
- iii) Father-in-law, mother-in-law, brother-in-law, sister-in-law, Daughter-in-law (iv) Relationship by legal adaptation.
