TENDER NOTICE

1. On behalf of the BHARAT SANCHAR NIGAM LIMITED, General Manger Telecom, BSNL, Kolar invites sealed tenders from the Manufacturers/Suppliers/Experienced Contractors "FOR THE REPAIR OF 25A/100A POWER PLANT MODULE" (Including supply of spares) in Kolar Telecom District. The details of work involved and the terms and conditions of tender are given in Annexure-"A".

2. The tender should be submitted in the prescribed proforma that may be obtained from Divisional Engineer (Planning & Development) office of the General Manager Telecom District Kolar on payment of Rs.113/- (Rupees One Hundred thirteen only) per copy, at the Cash Counter of the office of the General Manger Telecom District Kolar on all working days from **02-02-2009** to **16-02-2009** between **10.00 Hrs** to **15.00 Hrs**.

Sealed Tenders superscribed as "TENDER FOR THE REPAIR OF 25A/100A POWER PLANT MODULE" (Including the supply of spares) should be addressed to Sri S.Shivakumar, Divisional Engineer (P&D), O/o G.M. Telecom, BSNL, Kolar-563101 so as to reach him on or before **13.00 Hrs** of **17-02-2009**. The tenders will be opened in the presence of such of those tenderers or their agents as may choose to attend at 15.00 Hrs of **17-02-2009**.

Terms and Conditions

1. Each tender should be accompanied with Earnest Money Deposit (i.e. EMD) of **Rs.5,000/- (Rupees Five thousand only)** to be paid in cash at the cash counter of the office of the General Manager Telecom, BSNL, Kolar-563101 and the cash receipt should be enclosed along with the tender.

The Earnest Money Deposit (i.e. EMD) can also be paid in the form of Demand Draft drawn on any Nationalized Bank drawn in favour of Accounts Officer (Cash) O/o G.M. Telecom, BSNL, Kolar-563101, payable at Kolar. In such case DD should be attached to the tender.

2. Payment of E.M.D. is exempted for the following categories of tenderers.
 - i) Firms registered with D G S & D for supply of stores.
 - ii) Small scale industrial units which are listed with National Small Scale Industrial Corporation and in effect treated as automatically registered with D G S & D under revised scheme of single point registration.
 - iii) Public sector undertaking which are registered with the Department of D G S & D.
Photostat copies of necessary certificate issued by the concerned authorities and which shall be current should accompany the tender for claiming exemption.
- 3 The freight charges for the Power Plant Modules both ways for major repairs at the contractor's workshop shall be borne by the tenderer, if the unit cannot be repaired at the site.
- 4 Normally the work of repair/maintenance of the Power Plant is to be carried out at the site. The successful tenderer shall supply free of cost all spares and materials, which may be needed during servicing, repairs and overhauling.
5. The rates quoted should be per unit (Module). The rates must be quoted both in words and figures.
- 6 The rates quoted should be inclusive of all taxes, freight, excise duty etc. No extra charges should be quoted. Any correction in rates should be attested with the signature of the tenderer.
7. E.M.D. of the unsuccessful tenderers will be refunded without interest after following usual departmental procedures. The E.M.D. of the successful tenderer will be retained as security deposit which will not carry interest while in the custody of BSNL.
8. The tenderer who have earlier experience in repairing Power Plant Modules of BSNL will be given preference. Experience certificate signed by an officer of the rank of not less than a Divisional Engineer of BSNL to be enclosed. The tenderer should have proper infrastructure for taking up such type of work.

9. The tender should be submitted in the Annexure-B only and the Annexure-A should also be enclosed duly signed on each of the pages along with the tender in the Annexure-B.

10. The successful tenderer should execute an agreement of contract with department on a stamp paper of Rs. 50/- containing the terms and condition of the contact as finalized by this office. All the terms and condition of this tender form part of this agreement.

11. Loss/Damage to the Power Plant Modules:-

a) In case of loss/ damage to the Power Plant Module while in the custody of contractor, the cost of Power Plant Modules as per prevailing BSNL rates will be recovered from the contractor.

12. Penalty clause for Non-performance:-

a) The faulty Power Plant Module shall be repaired within the stipulated time as per para 3.2 of Annexure-A. If the contractor fails to repair the Power Plant Modules within the stipulated time a penalty of Rs. 100/- or part there of per Power Plant Modules shall be levied.

b) The repaired Power Plant Module are to be returned within the time period specified in clause 4.1 of Annexure-A. A penalty of Rs.100/- per week or part thereof per Power Plant Module or part thereof shall be levied by the BSNL, in case of delay.

c) There will be a warranty of 90 days for the Power Plant Modules repaired. Any further repair during the warranty period, is to be carried out at the cost of the contractor, failing which the cost of repair per Power Plant Module will be recovered from the contractor.

13. Termination of the contract:-

a) The contract will be terminated by the BSNL at any time without giving any notice in case of Non-Compliance of the terms and conditions of the tender

b) The decision of the General Manger, Telecom, Kolar shall be final and binding in this matter.

c) The BSNL shall be at liberty to award the work to more than one contractor from the selected panel of contractors.

14. 10% of total cost of repair of module in each bill shall be deducted as security deposit and same will be refunded after the warranty period as specified in the Tender.
15. The contractor has to pay all statutory duties/levies/Taxes etc., for the materials purchased and not hold the BSNL responsible.
16. Income Tax clearance certificate, if any has to be produced along with the Tender document.
17. The contractor should have registered with Service Tax/Professional Tax authorities and produce proof of the same.
18. Service TAX/ KST/CST will be deducted from each bill apart from the Income Tax and surcharge on Income Tax as applicable.
19. The General Manager Telecom, BSNL, Kolar reserves the right to reject any or all the tenders without assigning any reason and also the General Manager Telecom, Kolar is not bound to accept the lowest tender. In the said matter the decision of the General Manager Telecom, Kolar will be final and binding on all concerned.

Scope of Technical Specifications, Terms and Conditions.

1. Definition:-

1. The successful tenderer(s) whose tender is accepted and his successor (s) is/are termed as Contractors.

2. General:-

1. **Scope:-** The contractor shall repair the faulty Power Plant Modules which are manufactured and supplied by various manufacturers and which have outlived their warranty period as per BSNL specifications.

3. Collection of faulty Power Plant Modules and return of repaired Power Plant Modules:-

- 3.1 The faulty Power Plant Modules will be delivered by Sub Divisional Engineers at the site.
- 3.2 The concerned SDE/DE will intimate to the contractor, the quantity and type of Power Plant Modules lying faulty. This will be done through Telephone message confirmed in writing while handing over faulty Power Plant Modules.
- 3.3. The contractor shall ensure the collection of faulty Power Plant Modules within 3 days from the date of receipt of intimation as per cl. 3.1 above from the exchange through authorized person.
- 3.4 Power Plant Modules will be supplied back to the office from where they were collected with a slip to be pasted at the bottom of the Power Plant Modules indicating the date of repairs of the Power Plant Modules after due inspection by the BSNL staff.

The warranty will commence from the above date written on the slip.

4. Place, Scope and duration for repair.

- 4.1 The faulty Power Plant Modules duly repaired shall be delivered to the concerned SDE/DE within 5 days of its collection.

4.2 All faulty components replaced should be returned to the BSNL and a certificate to that effect should be given with each returns of the Power Plant Modules, cannibalising from other Power Plant Modules should be resorted to.

5. Inspection:-

5.1 A summary of fault found and details of faulty components, failures shall be supplied with each repaired Power Plant Modules.

5.2 After carrying out the repairs of Power Plant Modules the same will be offered for inspection by the BSNL staff of respective units.

5.3 The inspection shall be carried out by the nominee of the officer issuing the Power Plant Modules for repair. Each Power Plant Module inspected and passed shall be stamped with date of inspection.

6. Rate:- The tenderer should quote the rates inclusive of all spares to be used for repairing the Power Plant Modules in the Annexure.

7. Warranty of repairs:-

7.1 The contractor will ensure normal performance of the Power Plant Modules for a period of **90 days** from the date of inspection. Necessary repairs shall be carried by the contractor free of cost in case of any fault occurring the power plant Modules during the warranty period.

8. Period of validity of tender:-

8.1 The rate for the repairs shall remain valid for a period of one year from the date of acceptance of the tender which can be extended for another year on the same terms and condition on mutual consent.

9. Payment:-

9.1 The following documents shall be presented to enable the release of the payment-

Bills in triplicate, duly pre-stamped receipt indicating the quantity, type, make, date of collection, date of delivery. Payment will be made by the Accounts Officer (Cash), O/o General Manager Telecom, Kolar, BSNL, through A/C Payee Cheque. **PAN shall be indicated in the bills invariably.**
