- 1.4 The Sealed Limited tenders will be opened by AGM (Plg.) O/o GMTD Bijapur or by any Officer authorized by him at **1530 hours** on **27-10-2009**, in the presence of such of those Limited tenderers or their representatives who may choose to be present.
- 1.5 The Limited Tender should have registration certificate under KST/CST/VAT/PAN as applicable.

II. DEPOSITS:

1. Each Limited tender should be accompanied by an EMD of Rs. 3000/- (Three Thousand Hundred) only in the form DD drawn in favor of the Account Officer (Cash) BSNL O/o G.M.T.D.Bijapur. Tender without EMD will be rejected. The EMD of the successful tenderer will be forfeited if the tender is withdrawn after opening of the tender fail to execute an agreement bond.
2. EMD of the successful tenderers will be retained with BSNL as security deposit and will not carry any interest.

III. TERMS AND CONDITIONS.

1. The material should be supplied as mentioned in purchase order. If items get damaged in transportation same should be replaced by new one without any extra charge.

2. The approximate requirement of

a) VPT Sign boards 2ft X 1.5ft → 1000 Nos

b) RSU Telephone Exchange Sign boards and CSC sign boards size 4ft X 3ft → 50 Nos

c) Rural Telephone Exchange Sign boards 2ft X 3ft → 150 Nos

This requirement is subject to variation of + - 25% quantity.

3) All Telephone exchange sign boards and CSC sign boards of size 2ft X 3ft and 3ft X 4ft should be supported with iron frame and with three numbers of hooks fixed for each board.

4) For VPT Sign boards the background colour should be of yellow colour with red borders. And with letters written in blue colour

5) For Telephone Exchange / CSC Sign boards the background colour should be of Navy Blue colour with White borders and with letters written in white colour.

If necessary colour combination may differ at the time of issuing work order.

6) Payment terms: The payment will be made 90% after receipt of the materials. The balance amount 10% will be made after warranty period/validity period of the tender. 90% bill should be submitted in triplicate and 10% bill will be submitted in triplicate after warranty period / Validity period.

3. The GMTD BIJAPUR has got the right to accept / reject the whole / part of tender. Any dispute will be settled by the the decision of the BSNL Arbitrator who will be nominated by the GMTD BIJAPUR.

7. The validity period of Tender will be One Year from the date of acceptance at the same rate and conditions. No extensions will be issued.

8. The supplier should be registered under CST/KST/VAT (at least any one of them). Xerox copy of registration certificate of CST/KST/VAT is to be enclosed to the tender document.

9. Any attempt for negotiation either direct or indirect on the part of the Tenderer to influence by any means, the acceptance of the tender will render the Tenderer liable to be exclude from consideration.
