NOTICE INVITING TENDER

Sealed Tenders are invited by the General Manager Bijapur Telecom District, BIJAPUR for supply of 12 Volts 7AH SMF VRLA Battery MONO Block of size 15 cm x 6 cm x 9 cm (Length x Breadth x Height) to be used in SMPS charger for CDMA FWT instruments. Battery supplied should be compatible for using in CDMA FWT SMPS charger terminal of any make such as Terracom, ACD, Vuppula etc. The quantity of Batteries required is about 1000 Nos approximately.

The firms or Vendors participating in the tender should be , Authorised Suppliers /Service Dealers (ASD) of reputed Manufacturers/suppliers *etc* . 1. DEPOSITS

- 1.1 Each tender should be accompanied by an EMD of Rs10,000/- (Rupees Ten thousand only) towards **BID SECURITY** in the form of Demand Draft drawn in favour of the ACCOUNTS OFFICER (CASH) B.S.N.L. o/o GMTD BIJAPUR. Tender without EMD will be rejected. The EMD of the successful tenderer will be forfeited if the tender is withdrawn after opening of the tender or fail to execute the agreement.
- 1.2 EMD and Additional Security Deposit (ASD) of successful tenderers will be retained with BSNL as Security Deposit during the Warranty period of Items supplied (One Year) and EMD of unsuccessful tenderer will be refunded after finalisation of the tender. EMD/SD while in the custody of the BSNL will not carry any interest.
- 1.3 Within Seven days from the receipt of the provisional acceptance letter from this office, in addition to the EMD, the successful tenderer should pay Rs 10,000/- towards Additional Security Deposit. Additional S D (ASD) can be paid in the form of Demand Draft in favour of Accounts Officer (cash)BSNL o/o GMTD Bijapur, or Bank Guarantee equal to ASD valid for two years from the date of award, failing which, his EMD will be forfeited to the BSNL BIJAPUR TD. The EMD / SD amount will not attract any interest during contract period.
- 1.4 The SD will be forfeited to the BSNL without prejudice to any other rights in the following circumstances.
 - a).In the event of contractor failing to observe or perform any of the conditions of the work as set out therein.
 - b).In the event of not complying with orders/instructions issued by the BSNL.

2. TERMS AND CONDITIONS

- 2.1 Incomplete and Conditional Tenders will not be accepted.
- 2.2 The tender rates once accepted will be valid for a period of six months from the date of acceptance of the tender.
- 2.3 Warranty Period : Warranty period will be one year from the date of supply and any battery goes faulty in warranty period the same should be replaced without any extra charge.
- 2.4 The Contractor shall under no circumstances sublet the Contract.
- 2.5 The BSNL, is not responsible and shall not pay the loss or damage if any caused to Contractor's persons/materials incurred while carrying out the contract.
- 2.6 In case of any dispute/matter arising out of this contract, the matter will be referred to the sole arbitration of the GMTD Bijapur or any other persons nominated by him whose decision will be final and binding.
- 2.7 The Pre-Receipted bill in triplicate along with acknowledged consignment note receipt or work order, and the certificate regarding the items received in Good Condition from SDE(MM) BIJAPUR the Consignee should be submitted within a week after completion of work in the name of & to the AGM(PLG) o/o GMTD Bijapur for effecting 90 % payment of total bill for effecting the payment. Remaining 10 % bill to be submitted after completion of warranty period of one year.**

- 2.8 The Successful Tenderer will have to execute an agreement of Contract on a non judicial stamp paper of Rs. 50/- (Rupees Fifty only) duly incorporating as per the proforma given in ANNEXURE-III.
- 2.9 In case the Contractor fails to meet any of the terms and conditions of this Contract, the GMTD Bijapur is at liberty to terminate the Contract and forfeit EMD/SD in favour of the BSNL.
- 2.10 The GMTD Bijapur reserves the right to reject any or all Tenders in full or part without assigning any reasons and it is not binding on him to accept the lowest tender only.
- 2.11 The validity period of this tender will be SIX MONTHS from the date of final confirmation of the acceptance of tender.
- 2.12 EVALUATION OF TENDER :L1 will be decided as per the lowest rate quoted and tender proposal fully complying to the technical specifications as per Annexure-II.
- 2.13 Penalty Clause:: The supplier has to supply the items within 30 days from the date of receipt of Purchase Order failing which a penalty of 0.2% per week subjected to a maximum of 2% of the total PO value will be levied.

3. DEDUCTION OF TAXES

The bills of the Supplier will be paid after deduction of the statutory taxes as applicable, after certification of satisfactory receipt of material by SDE(MM).

4. ARBITRATION

In the event of any question, dispute or difference arising under this agreement or in connection there with except as to matter the decision of which is specifically provided under this agreement, the same shall be referred to the sole arbitration of the General Manager Telecom, BSNL BIJAPUR or by any person appointed by the said officer. The agreement to appoint the arbitrator will be in accordance with the Arbitration and consolation Act-1996.
