SECTION II

INSTRUCTIONS TO BIDDERS

SERVICES TO BE PROVIDED

1. Services to be provided: are given in Section VI

2. <u>Eligible Bidders</u>

- (a) The bidder should own or on lease vehicles of model not older than year 2005 registered as commercial vehicles in their names or Firm's name for use as commercial vehicles. The proof of ownership or lease holding should be produced along with the bid.
- (b) The vehicle should have comprehensive insurance with the Insurance Companies recognized by the Government of India and valid for this contractual period.
- (c) The bidder shall also submit full details of the vehicles that can be assigned in their favour and shall give a clear declaration that the firm will be able to supply commercial vehicles of model not older than 2005.
- (d) The bidder shall have experience of minimum period of 1 year for similar type of contract of supplying not less than <u>2</u> Commercial vehicles / cars to Govt. organization or any large Public Sector Undertaking / Institution (documentary proof to be enclosed to the bid).
- (e) The bidder should produce service tax registration certification from Central Excise and the service tax will claimed in bill. The same has to be paid to central Tax authorities and receipt be produced.
- (f) The bidder can bid for any No.of vehicles listed in section V, provided EMD of Rs.10,000/- (Rs. Ten Thousand Only) is paid for each vehicle.

3. Cost of Bidding.

The bidder shall bear all costs associated with the preparation and submission of the bid. BSNL in no case be responsible for these costs regardless of the conduct or outcome of the bidding process.

4. Bid Document

- 4.1 Bid document includes
- a. Notice Inviting Tender
- b. Instructions to bidders
- c. General condition (Commercial) of the contract
- d. Special conditions of contract
- e. Schedule of requirement and Hire charges
- f. Services to be provided
- g. Bid form and price schedule
- 4.2 The bidder is requested to examine all instructions, forms, terms and specification in the Bid documents. Failure to furnish all the information required as per Bid Documents or submission of the bids not substantially responsive to the Bid Documents in every respect will be rejected.
- 4.3 A prospective bidder requiring any clarification on the Bid document shall notify the BSNL in writing. The BSNL shall respond in writing to any request for the clarification of bid document which it receives not later than 3 days prior to the date of opening of Tender.
- 5. Documents required to be submitted for establishing Bidders Eligibility and Qualifications along with the bid documents.
- i. The bidder shall furnish the particulars of past performance with supporting documents.
- ii. Partnership Deed proprietorship deed/ lease deed.
- iii. Latest income tax clearance certificate (ITCC).
- iv. EPF and ESI registration certificate should be produced.

6. Amendment to bid document

- i. At any time, prior to the date of submission of bid, BSNL may, for any reason whether at its own initiative or in response to a clarification required by a prospective bidder, modify the bid documents by amendments.
- ii. The amendments shall be notified in writing to all prospective bidders and these amendments will be binding on them.

7. <u>Documents comprising the bid</u>

The bid prepared by the bidder shall comprise the following components.

- a. Documentary evidence established in accordance with clause 2 that the bidder is eligible to bid and is qualified to perform the contract if his bid is accepted.
 - (i) In case of leased vehicle copy of lease deed duly registered.
- b. Bid security furnished in accordance with clause 11.
- c. A clause by clause compliance as per clause 10.
- d. Bid Form and price schedule completed in accordance with clause 8 and 9.

8. Bid Form

The bidder shall complete the Bid Form and the appropriate price schedule furnished in the bid document covering the services to be rendered quality and price schedule as per Section-V.

9. Bid Price

- i. The bidder shall quote as per price schedule given in section V for all types of vehicles given in the schedule of requirement giving.
- ii. The price quoted by the bidder shall remain fixed during entire period of contract & shall not be subject to variation on any account. Conditional bids are liable for rejection.

10. Clause by clause compliance

A clause – by – clause compliance of service to be provided (SECTION VI), and special condition (Section IV) shall be given. In case of deviation a statement of deviation shall be given.

11. <u>EMD</u>

- 11.1 The bidder must deposit Rs.10,000/- (Rupees Ten thousand only) for each vehicle. He should attach cash receipt issued by the Accounts officer, (Cash) O/o GMT, BSNL, DVG or DD drawn in favour of BSNL, DVG payable at nationalized bank at Davangere to the bid document.
- 11.2 The successful bidders EMD will be converted as Security Deposit. This Security Deposit will be refunded after completion of the tender period and will not bear any interest.

11.3 The EMD may be forfeited:

- a) If bidder withdraws his bid after quoting the rates.
- b) If the successful bidder fails
 - i) to sign contract in accordance with clause 18
 - ii) to furnish performance security in accordance with clause 2 of section III
 - iii) The EMD of unsuccessful bidder will be returned as early as possible but not later than 30 days after the finalisation of tender. However, this EMD will not bear any interest.
- 12. All pages shall be signed by the bidder.

13. Submission of bid

- i) The bids should be submitted in a sealed cover, superscribed as "Tender for HIRING OF VEHCILE" and addressed to ASST.GENERAL MANAGER(ADMN). O/o GM Telecom, Davangere shall be dropped in tender box kept in ASST.GENERAL MANAGER(ADMN)'s chamber on or before due date and time. The sealed tenders may also be sent through registered post addressed to ASST.GENERAL MANAGER(ADMN) O/O GM Telecom, Davangere so as to reach him on or before the due date and time specified.
- ii) Any bid received after the due date & time for submission of bids shall be rejected and returned to the bidder.
- iii) Technical Bid and financial Bid should be submitted in separate covers.

14. Bid opening

BSNL shall open bids in a the presence of bidders or their authorized representative who wish to be present at the time of opening of bids on due date. Authorization letter to this effect shall be submitted by the bidder before they are allowed to participate in bid opening.

15. Evaluation

- 15.1 BSNL shall evaluate the bids to determine whether they are complete, whether any computational errors have been made whether documents have been properly signed and whether bids are generally in order.
- 15.2 If there is a discrepancy between words and figures the amount in words shall prevail prior to detailed evaluation, BSNL will determine the substantial responsiveness of each bid to the bid document. A substantially responsive bid is one, which confirms to all the terms and conditions of bid documents without material deviation. A bid determined as substantially non-responsive will be rejected by BSNL.
- 15.3 BSNL shall evaluate in detail and compare the substantially responsive bids and comparison of bids shall be on the price of the services offered inclusive of all levies and charges as indicated in the price schedule in section V of the bid document.

- 15.4 In case the L1 tenderer is unable to supply the full requirement of vehicle as per schedule-V remaining requirements will be offered to next bidder if he is willing to supply the vehicle at L1 rates @ same terms and conditions.
- 15.5 If more than one bidder becomes L1 the bidder who has offered maximum No. of vehicles for a particular place will be given first preference.

16. Award of Contract

BSNL shall consider placement of letter of intent to those bidders who have entered into agreement with BSNL for the supply of vehicle within the stipulated period and whose offers have been found technically, commercially and financially acceptable. The bidder shall within 7 days of issue of letter of intent, supply the required vehicle in full. If the bidder fails to supply the required number of vehicles BSNL reserve the right to forfeit the amount of EMD for the vehicle not supplied. Extension of time for 7 days only for supply of vehicles at the place, will be considered if sufficient and satisfactory reasons are furnished with documentary evidence. If the bidder fails to supply the vehicles in full even after the expiry of extended period, the EMD will be forfeited for the vehicle not supplied.

17. Right to vary quantities

BSNL reserves the right at the time of award of contract to increase or decrease upto 25% of the required quantity of services specified in the schedule of requirements without any change in hiring charges of the offered quantity of other terms and conditions.

18. Signing of Contract

Signing of agreement shall constitute the award of hiring contract on the bidder. The tenderer has to enter to an agreement with the BSNL within 7 days from the receipt of such a letter. If he fails to enter into the agreement the EMD will be forfeited.

19. Annulment of Award

Failure of the successful bidder to comply with the requirement of clause 18 shall constitute sufficient ground for the annulment of the award and forfeiture of the bid security in which event BSNL may make the awards to any other bidder at the discretion of BSNL or call for new bids.

20. Period of validity

One year from the date of Award of contract.

SECTION III

GENERAL (COMMERCIAL) CONDITIONS OF CONTRACT

1. Application

Submission of bid against this offer shall bind the bidder for the acceptance of all the conditional specified herein or in NIT unless otherwise agreed by BSNL.

2. If the contractor fails or neglects any of his obligations under the contract it shall be lawful for BSNL to forfeit either whole or any part of security deposit..

3. EXECUTION TIME LIMIT

3.1 The time period as stipulated in the contract or letter of intent shall be deemed to be essence of the contract.

4. PAYMENT TERMS

Monthly bills shall be submitted in duplicate to the authority specified in contract along with log book duly signed by the user and counter signed by the DE.

5. Termination of Contract

- 5.1 BSNL may without prejudice to any other remedy for breach of contract may terminate the contract in whole or in part.
- a) If the contractor fails to arrange the supply of any or all of the vehicles within the period(s) specified in the contract or any extension thereof granted by BSNL.
- b) If the contractor fails to perform any other obligation (s) under the contract.
- c) The General Manager reserves the right to withdraw any vehicle without prejudice to any other remedy with the notice of one month to the contractor.

6. Termination for insolvency

BSNL may also by giving written notice and without compensation to the contractor terminate the contract if the contractor becomes insolvent without affecting its right of action or remedy as hirer.

7. Force Majeure

If any time, during the continuance of this contract, the performance in whole or in part by either party of any obligation under this contract is prevented or delayed by reason of any war, or hostility, acts of the public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics, guarantee restrictions, strikes, lockouts or act of God (Hereinafter referred to as events) provided notice of happenings, of any such eventuality is given by either party to the other within 21 days from the date of occurrence thereof, neither party shall be reason of such events be entitled to respect of such on performance or delay in performance under the contract shall be resumed as soon as practicable after such an event may come to an end or case of exist, and the decision of BSNL as to whether the supplies have been so resumed or not shall be final and conclusive, provided further that if the performance in whole or part of any obligation under this contract is prevented or delayed by reason of any such event for a period exceeding 60 days either party may, at his option terminate the contract.

8. Arbitration

- 8.1 In the event of any question, dispute or difference arising under the agreement or in connection there with (except as to matter the decision to which is specifically provided under this agreement), the same shall be referred to arbitrator appointed by B.S.N.L., Davangere. The decision of the arbitration is binding on both the parties.
- 8.2 The arbitrator may from time to time with the consent of both the parties enlarge the time frame for making and publishing the award. Subject to aforesaid arbitration and conciliation Act, 1996 and the rules made there under, any modification thereof for the time being in force shall be deemed to apply to the arbitration proceeding under this clause.
- 8.3 The venue of the arbitration proceeding shall be office of <u>G.M.</u> Telecom, <u>BSNL</u> at <u>Davangere</u> or such other place as the arbitrator may decide.
- 8.4 The legal jurisdiction is Davangere in case of any disputes arise.

9. <u>Set Off</u>

Any sum of money due and payable to the contractor (including security deposit refundable to him) under this contract may be appropriated by BSNL and set off the same against any claim of BSNL for payment of a sum of money arising out of this contract or under any other contract made by contractor with BSNL.

SECTION IV

SPECIAL CONDITIONS OF CONTRACT

- 1. The special conditions of contract shall supplement the instruction to the Bidders as contained in section II and general (commercial) conditions of the contract as contained in section III and wherever there is a conflict, the provisions herein shall prevail over those in section II and section III.
- 2. In case the date fixed for opening of bids is subsequently declared as holiday by the Government of India, the revised schedule will be notified. However, in absence of such notification, the bids will be opened on next working day, time and venue remaining unaltered.
- 3. BSNL reserves the right to disqualify such bidders who have a record of not meeting contractual obligations against earlier contract entered into with BSNL.
- 4. BSNL reserves the right to blacklist a bidder for a suitable period in case he fails to honor his bid.
- 5. The liability under relevant sections of Motor Vehicle Act 1968 and IPC causing death or permanent liability developed in the vehicle supplied by the contractor, the hiring authority has no responsibility of whatsoever and will not entertain any claim in this regard under the provision of the law.
- 6. The engagement and employment of drivers and payment of wages to them as per existing provisions of various labour laws and regulations is the sole responsibility of the contractor and any breach of such laws or regulations shall be deemed to be breach of this contract.
 - The on duty drivers while touring to Bangalore , must preferably aware the routes for the locations at Bangalore and traffic rules.
- 7. No sub-contracting is permissible by BSNL. The near relatives of all BSNL employees are prohibited from participation in this tender. The near relatives for this purpose are defined as:
- a) Members of a Hindu Undivided Family.
- b) They are husband and wife,
- c) The one is related to the other in the manner as father, mother son(s), Son's wife (daughter-in-law), Daughter(s) & daughter's husband (son-in-law), brother(s)& brother's wife, sister(s) & sister's husband (brother-in-law).

- 8. The tenderer(s) should give a certificate to the effect that non of his / her such relative is working in the BSNL as defined above. In case of proprietorship firm the certificate will be given by the proprietor, for partnership firm certificate will be given by all the partners and in case of Limited company by all Directors of the Company. Any breach of these conditions by the company or firm or any other person, the tender / work will be cancelled and earnest money / security deposit will be forfeited at any stage whenever it is noticed. The BSNL will not pay any damages to the company or firm or concerned person. The company or firm or the person will also be debarred for further participation in the concerned unit.
- 9. The contractor shall assign the job of driving of hired vehicles only to qualified experienced licensed drivers and also assume full responsibility for the safety and security of the officers / officials as well as essential store items while running the vehicle by ensuring safe driving. BSNL shall have no direct or indirect liability arising out of such negligent, rash and impetuous driving which is an offence under section 29 of IPC and any loss caused to BSNL have to be suitably compensated by contractor.
- 10. The contractor shall when called upon to do so, place at the disposal of BSNL such number of vehicles as may be required although the number of vehicles so demanded may be more than the number of vehicles he is required to supply for the purpose of execution of the contract at same rate and terms and conditions. The number of such vehicles to be supplied extra will not be more than 25% or original schedule or requirement in the NIT.
- 11. In no case a vehicle which is not registered for the commercial purpose shall be supplied to BSNL and taxes etc., due on such vehicles shall be liability of the contractor.
- 12. The contractor shall send the vehicle for periodical servicing at his cost. BSNL will not pay any mileage run for such servicing. The vehicle Km run not for BSNL works will be deducted from the total kms run during that month. The cost of lubricants, repairs, maintenance, taxes (service tax existing /taxes of Central & State Govt as and when applicable) insurance, etc. will be to the contractor's liability.
- 13. BSNL reserves right to counter offer price against price quoted by the bidder.
- 14. It is not binding on the BSNL to award the work to the lowest bidder.
- 15. Regular checking of meter by the designated transport authority may be done by the contractor, and requisite certificate may be shown to BSNL once in three months.

The "Contractor" has deposited Rs (Rupees) as interest free Performance Security.

1. The Contractor shall during the period of this contract that is to say from to or until this contract is determined by such notice as herein after mentioned, will provide commercial vehicles not older than three year model, on the rates accepted as described in schedule vide appendix-I to this agreement. It is agreed by the Contractor that number of vehicles required is likely to change and may be demanded according to the exigencies of service by BSNL.

3. The authorities of BSNL indicated in appendix-II shall place an order for their requirement on the official Hire order form appendix-III (herein after called Hire order) and will receive acknowledgement from the Contractor for supply of vehicles. It is anticipated that the Contractor will supply vehicles to these authorities on regular basis until such time the contract is valid and the parties in agreement are satisfied with the performance of the contract.
4. The Contractor agrees with the BSNL and with each authority competent to order that every contract of hire order should be subject to the terms of this Agreement for vehicle Hire and in the event of a conflict between these terms and the terms in hire order, the terms of this Agreement for vehicle Hire shall prevail.
5. Contractor will provide vehicles to BSNL not older than three years and registered for the commercial purpose only and taxes, insurance etc. due on such vehicles shall be the liability of the contractor.
6. The Contractor should provide the particular model or make of vehicle as agreed upon in the contract. The BSNL only reserves the right to substitute it with another similar vehicle. If for any reason whatsoever the BSNL is not happy with the condition of the vehicle provided, the Contractor's nearest office will be informed immediately and they should accept any liability to replace it as per requirement. If for any reason the Contractor is not in a position to provide a substitute vehicle as demanded by the BSNL then the BSNL will be free to engage a vehicle from the open market and debit the expenditure on account of it on the claims payable to the Contractor

7. Contractor will submit bills in accordance with Section-III, Clause (4) of the tender document to the Section of, of BSNL on monthly basis for release of payment by BSNL.
8. The driver of the vehicle shall always hold a valid Photo Identity Card issued by the BSNL Office or any other local Central / State govt. office competent to issue such cards as per Section-VI, clause 10(VI) and also carry duty slips printed by the contractor as per the Format shown in Section-XI where the date, time, KMs reading, purpose and places visited are to be filled in and signed by the Users / BSNL officials.
