TERMS AND CONDITIONS

- 01. The description of specification is in **Annexure-1**.
- 02. The rates quoted should be inclusive of TAXes, Levies and packing & forwarding chargein Annxure-II
- 03. The Tenderer will have to deposit an Earnest Money of Rs.5000,/- (Rs.Eive thousand only) non interest bearing, by DD drawn on any Nationalised / scheduled Bank payable at Gulbarga drawn in favour of Accounts Officer (cash) 0/0 the G M Telecom (BSNL) Gulbarga, near H P O Gulbarga-585101. The tender without Earnest Money Deposit (EMD) will not be considered.
- 04. The EMD of the successful tenderer will be converted as security deposit. In addition to EMD already paid by the successful tenderer he has to pay Rs 5000/- as additional security deposit so that the total SD is Rs 10,000/-. The security deposit will not carry any interest. The successful Tenderer has to enter into an Agreement on a Stamp Paper
- 05. Earnest Money Deposit (EMD) is liable to be forfeited if the tenderer resiles from the offer OR fails to enter into an agreement. EMD of unsuccessful Tenderer will be refunded after the finalisation of tender on production of pre-stamped receipt.
- 06. The Tender cover should be super-scribed as "TENDER FOR SUPPLY OF COMPUTER PERIPHERALs" and should be addressed to SRI M.K. Vagger AGM (PLG) O/o THE G M T D GULBARGA, NEAR H P O GULBARGA 585101.and it should be put into the tender box kept in the chamber of AGM (PLG) O/o the GMT Gulbarga.
- 07. The tender forms will be issued by the S D E (Plg) O/O the GMTD Gulbarga on all the working days up-to 12-30hrs of 06-05-09.on payment of Rs. 563/-(500+63 ST) (Rs five hundred sixty three only) at Cash Counter 0/O the GMTD Gulbarga.
- 08. The last date for acceptance of tender forms is 06.05.2009 up to 1500 hours. The tender will be opened on the same day at 1530 hours in the presence of the tenderers OR their representatives if any. Only one person per tender will be allowed to attend for tender opening.
- 09. ELIGIBILITY: Manufacturers/ authorized dealers/ suppliers having experience in such type works.
- 10. The contractor shall not assign OR sublet the work.
- 11. Each page of the tender schedule and annexure should be signed by the tenderer. Also any correction made should be signed by the tenderer.

- 12. If, the last date for receipt of tender happens to be a holiday the same will be extended to the next working day at the same time.

- 15. The General Manager Telecom District Gulbarga reserves the right to engage more than one contractor to meet the time schedule for the supply.
- 16. After the acceptance of tender, if the tenderer fails to enter into the agreement, the tenderer is liable to be blacklisted and will not be allowed to participate in the future tenders and his EMD/SD will be forfeited.
- 17. The successful tenderer should enter into an agreement on Rs.100/- (Rs one hundred only) stamp paper. The cost of the stamp paper should be borne by the contractor.
- 18. The tenderer not confirming to the above conditions will be rejected.
- 19. In case of breach of any of the conditions, the tender is liable to be cancelled, resulting in forfeiture of Security deposit.
- 20. The decision of the General Manager Telecom Gulbarga is final and binding on all the contractors.
- 21. **VALIDITY.** The tender will be valid for one year from the date of acceptance. No escalation will be allowed during this period.

- 22. **PAYMENT**: 90% Payment will be made after supply of materials, 10% after completion of tender period.
- 23. **PENALITY**. The contractor should supply the materials within the delivery period mentioned in the purchase order. Failing which a sum of Rs, 100/- (Rs, One hundred) per day will be charged as penalty upto the maximum of Rs. 5,00/- (Rs, five hundred) only per PO. If the contractor fails to supply the materials within seven days after the lapse of delivery period the contract will be cancelled and SD will be forfeited.
- 24. **WARRANTY**. Any deficiencies the contractor shall repair/replace it at his own cost. They will also guarantee against the faulty material supplied by them for one year.
