TENDER NOTIFICATION

On behalf of BHARAT SANCHAR NIGAM LIMITED, limited sealed tenders are invited by the General Manager Telecom District Gulbarga from the suppliers for the supply of Internal battery & AC-DC, adapter for WLL CDMA FWTs.

TERMS AND CONDITIONS

- 01 The description of specification is in **Annexure-1**.
02. The rate quoted should be inclusive of TAXes, Levies and packing & forwarding.
03. The Tenderer will have to deposit an Earnest Money of Rs.37500,-(Rs. Thirty seven thousand five hundred) non interest bearing , by DD drawn on any Nationalised /scheduled Bank payable at Gulbarga drawn in favor of Accounts Officer (Cash) O/o the G M Telecom (BSNL) Gulbarga, near H P O Gulbarga- 585101. OR can be paid by cash in the cash counter O/o GMTD Gulbarga and the cash receipt should be enclosed to the tender. The tender without Earnest Money Deposit (EMD) will not be considered.
- 04 EMD of the successful tenderer will be converted as security deposit. In addition to EMD already paid by the successful tenderer he has to pay Rs 37500/- as additional security deposit so that the total SD is Rs75,000/-. The EMD/SD while in custody of BSNL, will not carry any interest. The successful Tenderer has to enter into an agreement on a Stamp Paper .
- 05 Earnest Money Deposit (EMD) of the successful tenderer is liable to be forfeited, if the tenderer rescinds from the offer OR fails to enter into an agreement. EMD of unsuccessful Tenderer will be refunded after the finalisation of tender on production of pre-stamped receipt, or within two months from the date of opening of tender, whichever is earlier.
- 06 The Tender cover should be super scribed as “**TENDER FOR SUPPLY OF INTERNAL BATTERY FOR WLL CDMA FWTs** ” and should be addressed to **SRI M.K. Vagger. AGM (PLG) O/O THE G M T D Gulbarga, Near H P O GULBARGA – 585101.**and it should be put into the tender box kept in the chamber of **AGM (PLG) O/o the GMT Gulbarga.**
- 07 The tender forms will be issued by the S D E (Plg) O/O the GMTD Gulbarga on all the working days up-to **12-30hrs of 17-08-09.**on payment of Rs.563-(500+TAX) (Rs Five hundred sixty three only) at Cash Counter O/o the GMTD Gulbarga. or tender document may also be be down loaded from our website www.karnatakabsnl.co.in. Tenderer should enclose /cash receipt or DD of Rs 563/- drawn on any Nationalised /scheduled Bank payable at Gulbarga drawn in favor of Accounts Officer (Cash) O/o the G M Telecom (BSNL) Gulbarga, along with tender.
- 08 The last date for acceptance of tender forms is **17. 08. 2009 up to 1500 hours.** The tender will be opened on the same day **at 1530 hours** in the presence of the tenderers OR their representatives if any. Only one person per tender will be allowed to attend for tender opening.
- 09 **ELIGIBILITY: Manufacturer/Suppliers/Dealer**, necessary documents should be enclosed to the tender for showing evidence of the same.
- 10 The contractor shall not assign OR sublet the work.
- 11 Each page of the tender schedule and annexure should be signed by the tenderer. Also any correction made should be signed by the tenderer.

- 12 If, the last date for receipt of tender happens to be a holiday the same will be extended to the next working day at the same time.
- 13 The Total quantity of requirement is approximately **5000 (+/- 25%)**.

- 14 The General Manager Telecom District Gulbarga reserves the right to reject any or all tenders received without assigning any reasons and will not be bound to accept the lowest tender
- 15 The General Manager Telecom District Gulbarga reserves the right to engage more than one contractor to meet the time schedule for the supply.
- 16 After the acceptance of tender, if the tenderer fails to enter into the agreement, the tenderer is liable to be blacklisted and will not be allowed to participate in the future tenders and his EMD/SD will be forfeited.
- 17 The successful tenderer should enter into an agreement on Rs.100/- (Rs one hundred) stamp paper. The cost of the stamp paper should be borne by the contractor.
- 18 The tenderer not confirming to the above conditions will be rejected.
- 19 In case of breach of any of the conditions, the tender is liable to be cancelled, resulting in forfeiture of EMD / Security deposit.
- 20 The decision of the General Manager Telecom Gulbarga is final and binding on all the contractors.
- 21 **VALIDITY.** The tender will be valid for one year from the date of acceptance or till the completion of the supply of entire quantity. No escalation will be allowed during this period.
- 22 **PAYMENT :** 80% Payment will be made after receipt of consignment, 10% after Six months of working without failures or repaired within ONE WEEK in case of any failure and balance 10% after satisfactory working/ servicing during warrantee period of ONE Year.
- 23 **PENALTY.** The contractor should supply the materials within 15 days of period mentioned in the purchase order. Failing which a sum of Rs, 100/- (Rs, One hundred) per day will be charged as penalty up-to the maximum of Rs. 5,00/- (Rs, five hundred only per PO. If the contractor fails to supply the materials within seven days after the lapse of delivery period the contract will be cancelled and SD will be forfeited.
- 24 **WARRANTY.** Any deficiencies during the warranty period of its usage, the contractor shall repair or replace it at his cost. The tenderer shall also guarantee against any defects / failures in the equipment supplied for One Year and repair the faulty equipments FREE of cost at DRC Gulbarga with in ONE WEEK.
25. The contractor has to enclose the declaration in the proforma mentioned in the appendix
26. a) **Sample battery set /battery pack + Adapter to be submitted by the bidder.**
b) **Bidder shall be either original manufacturer or authorized dealer of the O.E.Ms. products.**
c) **Life of the battery to be clearly mentioned in terms of hours and charge discharge cycles.**
