On behalf of BSNL sealed Tender are invited by the General Manager Telecom District, Bijapur for "Supply of Solar Panel in Bijapur SSA. For Pilot project.

#### I. Submission of Tenders.

- 1. Tender should be submitted in prescribed form which may be obtained in person from the AGM(PLG) O/O GENERAL MANAGER TELECOM DISTRICT BIJPAUR.
- 2. Last date for issuing tender form is 06-11-2009 up to 1700 hrs.
- 3. the sealed tender should be sent by REGD POST/SPEED POST OR TO BE DROPPED IN TENDER BOX KEPT IN AGM(PLG) CHAMBER O/O GMTD BIJAPUR, so as reach to Sri. G S Sasanur AGM(PLG) O/O GMTD BIJAPUR at 1500 hrs of 07-11-2009, subscribed on the cover as "TENDER FOR SUPPLY OF Solar Pane in Bijapur SSA.
- 4. The sealed tender will be opened by AGM(PLG) O/O GMTD Bijapur OR By any officer authorized by him at 1530 hrs of 07-11-2009 in the presence of such of those tenderers or their representative who may choose to be present.
- 5. The tenderer should have registration certificate under KST/CST/VAT as applicable.

# II DEPOSITS

- 1. Each tender should be accompanied by an EMD of Rs. 5000/- (Rs. Five Thousand Only) in the form DD drawn in favour of the Accounts Officer(Cash) BSNL O/O GMTD Bijapur. Tender without EMD will be rejected. The EMD of the successful tenderer will be forfeited if the tender is with drawn after opening of the tender or fail to execute an agreement bond.
- 2. EMD of successful tenderers will be retained with BSNL as Security deposit and will not carry any interest.
- 3. The successful tenderer should pay Rs. 5000/- toward additional security deposit in the form of DD in favor of AO(CASH) O/O GMTD Bijapur and will not carry any interest.

#### **III** Terms and Conditions

- 1. Incomplete and conditional tenders will not be accepted.
- 2. The tender rates once accepted will be valid for a period of one year from date of acceptance of the tender.
- 3. The bill in triplicate along with acknowledged consignment note may be submitted for 90%. The balance 10% payment may be submitted after one year warranty period.
- 4. The successful tenderer should supply item within 30 days of receipt of work order from AGM(PLG) O/O GMTD Bijapur, in exchange building as per the details instructions from concerned SDEs and bills should be submitted in triplicate to concerned SDEs, failing which LD charges @ 0.5% per week of the value of the purchase order subject to the maximum of Rs. 2500/- will be deducted in the bill.
- 5. The charge controller not required. Existing battery back up will be utilised VRLA battery 24 Nos in series. IT IS A PIILOT PROJECT for 2 stations.
  - Technical condition: Area to be installed on roof top or plane land probable place in at Mulawad, Horti M/W ,Kolhar,Dulkehed & Revathagaon.
  - Capacity: 2KW peak + 10 %. Out put voltage 48 volt. Controllers of existing power Plant to be used. Solar Panel Multi crystalline type, area 10 Sq M per KW + 25%. All installation /wiring /installing of diode for avoiding reverse current should be included in the material as per Annexure Il each panel set of 4numbers delivering in 48 v with LED indication display to be visible inside the building. Existing Earth will be utilized and Helmeted type of Connector points to be given or cabling should be through pipe.
- 6. The items should be delivered on the site at the own cost of Tenderer. The installation and testing of items will be at own cost of tenderer
