# TERMS AND CONDITIONS FOR PURCHASE OF TOOLS AND HARDWARE FOR BELGAUM SSA FOR THE YEAR 2009-10

- 1. Eligibility: i) The supplier should have KST/CST/VAT Registration.
  - ii) The supplier should be the authorised dealer of the company.

### 2. Earnest Money Deposit:

- 2a) The tenderers will have to deposit EMD of Rs.10,000/- in the form of crossed D.D drawn in favour of the Accounts Officer(Cash), BSNL, Belgaum. EMD of the unsuccessful tenderer will be refunded after finalisation of the tender. EMD of the successful tenderer will be adjusted against the security deposit mentioned below and shall be retained for a period of One year from the date of acceptance. No interest will be paid on EMD / SD for the period held by BSNL.
- 2b) Payment of EMD is exempted for the SSI UNITS and the Guide-lines regarding the Concession to SSI Units are given below:
  - 2c) The EMD will be forfeited if the tenderer withdraws his tender after opening/acceptance.
- 3. Security Deposit: The EMD of the successful tenderer will be converted into part payment of the security Deposit. In addition to the EMD converted into SD, the successful tenderer will have to deposit an amount equivalent to the amount of EMD towards Security Deposit. Togetherly the total Security Deposit will be Rs.20,000/-. A crossed demand draft drawn in favour of Accounts Officer, BSNL, Belgaum for the balance amount after adjusting the EMD, should be deposited by the successful tenderer towards Security Deposit referred above within a period of 7 (seven) Days of the receipt of Tender Award letter from the undersigned.
- 3b) Payment of Security Deposit is exempted for the SSI UNITS and the Guide-lines regarding the Concession to SSI Units are given below:
- **4. CONCESSION TO SSI UNITS** ;- The guidelines issued by NSIC regarding concessions for Small Scale Industrial Units registered with NSIC under single point registration scheme were considered by the BSNL ( Corporate Office ) and it has been decided that these Units may be allowed the following concessions :
- i) Exemption from payment of Bid Security Deposit: The SSI units registered with NSIC shall be given exemption from payment of Bid Security, on production of the 'Registration Certificate', to the extent of their approved 'Monitory Limit'.
- **ii) Exemption from payment of Performance Security Deposit :** The SSI Units registered with NSIC may be given exemption from payment of Performance Security Deposit, on production of the 'Registration Certificate', for an amount upto their approved 'Monitory Limit' for which the unit is registered. If the 'Monitory Limit' of a SSI unit is classified as "without limit" by NSIC, then the maximum amount of 'Monitory Limit' for which such SSI unit will be entitled to get advantage of concession admissible to it, shall be limited to 50 lakhs only.
- 5. Rates: The rates must be quoted for all the items given in the enclosed 'Annexure-I' and the rates shall be exclusive of all taxes and its surcharge if any, and inclusive of cost of packing, freight, insurance loading, unloading etc. The details of taxes such as Sales Tax and Excise duty (if any) should be shown separately. The undersigned reserves the right to deduct all Govt.statutory levies and taxes ( such as Income Tax etc.) as applicable from time to time while making payment. It may please be noted that, quoting rates for all the items given in the enclosed 'Annexure-I' is mandatory, failing which, the tender shall be treated as an 'Incomplete Tender and the same shall not be considered for Evaluation Purpose.

- 6. The undersigned reserves the right to place order in part or in full. The items should be delivered to the consignee mentioned in the supply order at the supplier's cost (anywhere in Belgaum SSA).
- 7. Payment of Bills will be made after complete supply of the concerned Purchase Order by the tenderer. A certificate to that effect from the Consignee should be furnished on the bill. Proof of payment of Excise duty should be invariably enclosed to the Bill, or otherwise, the bill cannot be passed for payment.
- 8. The Tools and hardware shall be guaranteed for One year from the date of supply.
- 9. The quantity mentioned in the schedule is approximate and liable for variation. The successful tenderer is bound to supply additional orders to the extent 25% in normal case and upto 50% in case of emergancy, if any, at the same approved rates by this office during the validity period of the tender..
- 10. The G.M.Telecom Belgaum reserves the right to accept, reject or partly accept any quotation or reject all quotations without assigning any reasons at any stage of tender.
- 11. All bills for the supply of materials should be submitted in triplicate. Proof of payment of Excise duty (if any) should be invariably enclosed to the Bill, or otherwise, the amount towards 'Excise duty' cannot be paid.
- 12. Purchase order would be placed only after execution of the Agreement and on the payment of the Security Deposit as stated above.
- 13. The supplier shall take all precautions for safe delivery of the items. Risk in transit will be borne by the supplier.

## 14. .PENALTY CLAUSE :-

- 14.a) The items should be supplied within 20 days of the issue of Purchase Order. for delay in supply i.e beyond 20 days, the liquidated damages at the rate of Rs.100/- per day of delay / per P.O. shall be levied for a further period of Ten days. Beyond 10 days of delay, the purchaser is entitled to either reject the materials supplied and forefeit the EMD/SD and termination of the tender/black-listing the tenderer, or accept the materials duly recovering the L.D. charges at the rate of Rs.100/- per day of delay / per P.O. The quantum of L.D. Charges calculated by the purchaser shall be final and not challangable by the supplier.
- 14.b) If the items supplied are not confirming to the specifications of the tender, the EMD/SD of the contractor will be forfeited to BSNL for supply of sub-standard materials, and his tender will be terminated and his name will be black-listed in BSNL..
- 15. In the event of the tender being submitted by the firm it must be signed by the authorised signatory such as Manager, Agent etc. affixing his signature. Letter of authorisation should be enclosed to the tender.
- 16. Except otherwise specified in the terms and conditions all disputes be referred to the C.G.M. Telecom Bangalore whose decision is final and binding on both the parties.
- 17. Validity of the tender is One year from the date of final acceptance and the price approved should remain firm and valid for any work order which the BSNL may place within a period of One year from the date of acceptance of the tender and until its complete execution. No variation in price will be allowed within this period for whatever reason.

- 18. The successful tenderer has to enter into an agreement with the BSNL in non-judicial stamp paper of Rs.50/- (Rupees fifty only) as per prescribed form at Annexure III of Tender Documents. The agreement is required to the effect that the Tenderer (supplier) and the BSNL are bound by the Terms and Conditions in the agreement which in turn will be the same terms and Conditions as mentioned in the Tender Document.
- 19. The above items to be supplied by the Tenderer should be from a standard company / firm with reputed brand name fully adhering to the specification mentioned at Annexure I of this Document. The sample of the items should be made available as and when required.
- 20. The supplier would certify and affix his signature with seal on each and every page of the tender document and return it along with his tender offer as a token of his acceptance of each of the condition specified on each page of tender document
- 21. Detail Specifications for the Tools and Hardware are given in the enclosed 'ANNEXURE -I' and the rates should be quoted in the enclosed tender Form at 'ANNEXURE-I' itself..
- 22. Guarantee of the Tools and Hardware shall be One year from the date of supply.

#### 23. ARBITRATION:-

- 23.A) In the event of any question, dispute or difference arising under this agreement or in connection therewith except as to the matter the decision of which is specifically provided under this agreement, the same shall be referred to the sole arbitrator of the Chief General Manager Telecom, Karnataka Telecom Circle, Bangalore or by any person appointed by the said Officer The agreement to appoint the arbitrator will be in accordance with the Arbitration and Conciliation Act 1996.
  - 23.B) Jurisdiction of Court :- This contract is subject to jurisdiction of Court at Belgaum only.
- 24. <u>Evaluation</u>: The rate and quantity for a single item inclusive of all charges applicable (such as cost of packing, freight, insurance loading, unloading etc) and also inclusive of all other taxes <u>except Excise duties</u> shall be multiplied and total amount for all items together shall be compared to arrive at the lowest tender

#### 25. FORCE MAJEURE

- 25.1 : If, at any time, during the continuance of this contract, the performance in whole or in part by either party of any obligation under this contract is prevented or delayed by reasons of any war or hostility, acts of the public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics, quarantine restrictions, strikes, lockouts or act of God (hereinafter referred to as events) provided notice of happenings of any such eventuality is given by either party to the other within 30 days from the date of occurrence thereof, neither party shall by reason of such event be entitled to terminate this contract nor shall either party have any claim for damages against other in respect of such non-performance or delay in performance, and deliveries under the contract shall be resumed as soon as practicable after such an event come to an end or cease to exist, and the decision of the Purchaser as to whether the deliveries have been so resumed or not shall be final and conclusive. Further that if the performance in whole or part of any obligation under this contract is prevented or delayed by reasons of any such event for a period exceeding 60 days, either party may, at its option, terminate the contract.
- 25.2 Provided, also that if the contract is terminated under this clause, the Purchaser shall be at liberty to take over from the Supplier at a price to be fixed by the purchaser, which shall be final, all unused, undamaged and acceptable materials, bought out components and stores in course of manufacture which may be in possession of the Supplier at the time of such termination or a portion thereof as the purchaser may deem fit, except such materials, bought out components and stores as the Supplier may with the concurrence of the purchaser elect to retain.

- 26. **AMENDMENT**: In case of Amendment if any, the same will be published on the website: www.karnatak.bsnl.co.in, and the same shall be binding on the tenderer/tender conditions. It is the responsibility of the tenderer to check the website before submitting the tender.
- 27. APPEAL :- No Appeal against the decision of the Competent Authority will be entertained on the matters covered or not covered in the tender.

- iii) NSIC Registration certificate in case of SSI Unit claiming concession.

- v) Document in proof of the claim that, the supplier is the Authorised Dealer of Reputed Company to sell the Tools.
