

SECTION IV TERMS AND CONDITIONS

- **01.** Tender should be accompanied by a requisite EMD as mentioned in Para (2) of Section-I, as per the Zone, in the form of DD drawn in favor of **BSNL KODAGU TD, Madikeri.** The EMD can also be paid in cash at the cash counter of this office. No cheque, Postal order, Bank guarantee or Money order will be accepted.
- **02.** The tenderers should quote their rate per unit, inclusive of rates for spare parts (ie. rates for all the required spare parts including compressor replacement, if any, during the tender period). Taxes and other charges, if any, may be quoted separately, as per the proforma in the Financial Bid Form (Section VI), in figures & words.
- **03.** Tenderers should furnish their full address, telephone number, Income Tax PAN number, KST/CST/KVAT/WCT Registration No. etc... in the quotation.
- **04.** The EMD of the tenderer will be forfeited to the BSNL, if the tenderer withdraws his tender after opening of the tender.
- **05.** The EMD of the unsuccessful tenderer will be refunded only after approval of the Tender. The EMD/SD of the successful tenderer will be retained with BSNL as Security Deposit and will be refunded only after satisfactory completion of tender period. The EMD / SD while in custody of the BSNL will not carry any interest.
- **06.** In case, the work of maintenance is not executed within the stipulated date and time, the General Manager, Kodagu Telecom District, Madikeri reserves the right to get the work done through any other firms/agencies and in such event, the cost of carrying out the work from out side agency shall be reimbursed to the BSNL, by the tenderer.
- **07.** The repair/maintenance work should be carried out at Telephone Exchange site/office premises and in case of major repairs, where the units cannot be repaired at site, the unit may be repaired / serviced at the contractors workshop. No transportation / freight charges will be paid in such cases. No Travelling Allowance will be paid for maintenance/break down calls. The rate quoted should be inclusive of all charges (excluding Taxes)
- **08.** The spares required (including compressor) for the maintenance/repair work should be provided by the bidder himself. The validity of Tender period is **Two YEAR** from the date of signing the agreement. However, the General Manager, Kodagu Telecom District, Madikeri, reserves the right to terminate the tender contract at any time, if, the work performance is not satisfactory and if, maintenance/repair work is not carried out by the contractor, within the stipulated Period, along with forfeiture of EMD/SD.
- **09.** No advance payment will be made under this contract. The payment of the bills will be made by Accounts Officer (Cash), Office of General Manager, Kodagu Telecom District, Madikeri, against pre-receipted bill in duplicate, which should be submitted to GM Office, through respective JTOs/SDEs/DEs of the exchanges. **The bills should be submitted quarterly**.

- **10.** The General Manager, Kodagu Telecom District, Madikeri reserves the right to reject any or all the tenders without assigning any reason whatsoever and it is not binding on him to accept the lowest tender.
- 11. The damage done to the equipment during servicing/fault clearence shall be made good by the contractor at his cost.
- **12.** Statutory levies such as Income Tax, Work Contract Tax etc. Will be deducted from the bills at source as applicable from time to time at the time of passing the bills.
- **13.** Within 15 days, from the date of intimation, the successful tenderer should pay the required Security Deposit and execute an agreement (Section V) with the concerned Divisional Engineer, failing which the EMD will be forfeited.
- **14.** Incomplete and conditional tenders will be rejected. Quoting of unrealistic rates will be treated as disqualification.
- **15.** The General Manager, Kodagu Telecom District, Madikeri, reserves the right to award the tender to more than one tenderer.
- **16.** None of the near relatives of BSNL/DOT employees are permitted to participate in the tender or no one connected with or in the employment of BSNL/DOT shall ever be admitted as a partner of the contractor. In case, at any stage, it is found that the information given by the tenderer is false/in correct, the General Manager, Kodagu Telecom District, Madikeri shall have the absolute right to take any action as deemed fit without any prior intimation to the tenderer.
- **17.** The Company shall consider award of contract to only those of eligible bidders whose offers have been found technically, commercially and financially acceptable.
- **18.** The Tender which does not furnish correct and complete informations and not accompanied by the EMD/certificates claiming exemption are liable to be rejected.
- 19. The BSNL reserves the right to accept or reject any bid and contract without assigning any reason what-so-ever and without there by incurring any liability to the affected bidders on the grounds for the department action.
- **20.** In addition to the existing AC Units, this contract will also be applicable for any new AC Units, added at the present/new stations within the District.
- **21.** The tenderer should repair the Voltage stabilizers, AC units including the electrical wiring within 24 hours of reporting by the concerned user. Failure to attend, a penalty of Rs. 50/- per day will be charged with a case mark.
- **22.** At Present, AC Units are purchased and installed from different manufacturers. The successful tenderer shall be in a position to undertake the AMC for AC Units of any manufacturers.
- 23. The approved tenderer should take over all the AC Units on "AS IS where is BASIS (ie. the AC Units either in working condition or under faulty) The faulty AC units, if any, should be repaired by the approved tenderer, immediately after taking over of the same, as faulty AC units are also covered under AMC. The List of AC units available in KODAGUTD is enclosed to this tender. (Section VIII).
- **24.** The contractor should ensure that maintenance card/job card is prepared for the work done and got countersigned by the officer in charge of the installation. **The contractor shall under no circumstances sublet the contract.**

- **25.** The tenderer should have a fully equipped workshop at Madikeri with Telephone facility. Details of the workshop available may be furnished with necessary documents.
- **26**. Bills should be produced in the prescribed format serially printed incorporating KST / CST / KVAT/ WCT Registration No., IT PAN No, Service Tax registration No etc. as per standard.
- **27.** Bills will be settled within 30 days of receipt of the bills by GMT- Madikeri, subject to satisfactory certificates and requirements.
- **28.** The contractor shall obtain a valid license under Contract Labour (R&A) Act- 1971 before commencement of the work and shall continue to have the valid license until completion of contract work. The contractor shall follow all the contractors labour regulations while employing his labourers.
- **29.** The contractor should be fully aware of the "Provisions of EPF & Miscellaneous Provisions Act 1952 and Employees Provident Fund Scheme 1952." The contractor is responsible for the fulfillment/compliance of the said EPF Act 1952, in respect of labourers/employees engaged by him for performing the work of BSNL.
- **30.** Any attempt of negotiation or bringing influence by any means for the acceptance Of the tender will render the tender application liable to be rejected from consideration.

SCOPE OF THE CONTRACT

The contract will cover maintenance service of Window/Split Air Condition Units of different makes, including associated Voltage Stabilizers, installed in various Telephone Exchanges/Offices in KODAGU Telecom District,. The following services are required to be provided by the contractor during normal working hours.

- 01. Quarterly inspection and servicing of the Units.
- 02. Attending to the Units including Voltage Stabilizers, as and when required within 48 hours or within the stipulated time as reported by the concerned user. Failing to attend, a penalty of Rs. 50.00 per day will be charged, with a case mark.
- 03. Replacement of spare parts of AC Units, Voltage Stabilizers and Compressors have to be done at the cost of the tenderer during the contract period.
- 04. Repairing / overhauling the components of the equipment at site/contractors service station, including replacement of worn out parts (including compressor), when found necessary.
- 05. Compressor replacement should be done within 15 days from the date of Reporting failure.
- 06. Replacement of compressor is of same make and should have the Warranty/ Guarantee of minimum of ONE YEAR with warranty/guarantee card which should be handed over to the officer incharge of the installation.
- 07. Checking the unit performance duly conducting cooling test and checking the temperature at various locations.
- 08. Replacement of Air Filters, when found necessary.
- 09. If, any unit is declared unserviceable during the contract period/at the end of the contract period, cost of such AC units will be recovered from the contractor.
- 10. All the AC units including Voltage Stabilizers should be made over to BSNL in good condition after the end of the contract period. If, any unit observed to be not working after the end of the contract period, cost of repair of such AC units will be recovered from the contractor.
