## GENERAL TERMS AND CONDITIONS OF THE TENDER

### 1. ELIGIBILITY FOR SUBMISSION OF TENDER

Tenderers submitting the tenders should have the experience of having done the work of maintenance of Engine Alternators in the BSNL / other central or state government department / Public sector undertaking for at least one year during the last three financial years. Certificate to that effect, issued by Divisional Engineer of the respective BSNL/ Public sector undertakings may be enclosed.

### 2.0 INSTRUCTIONS AND DETAILS TO SUBMIT THE TENDER

The Tender filled up and signed on every page and duly sealed (By sealing wax) should be addressed to Smt Shymala Bhatt DE (Planning) O/O GMT, Kodagu Telecom District, Padmavathi Complex, Gowli Street, Madikeri 571 201, so as to reach on or before 14.00 Hrs on 23-9-2009 by registered post or by courier duly superscribed on the envelope as "TENDER FOR THE ANNUAL MAINTENANCE OF ENGINE ALTERNATORS (INCLUDING THE SUPLLY OF SPARES) IN KODAGU SSA FOR THE YEAR 2009-2011"

The tender shall be opened on the same day at 15 00 Hrs in the chamber of Divisional Engineer (Planning) Madikeri, in the presence of the tenderers who may be present at the time of opening of the tenders. Only one representative of the tenderer will be allowed at the time of opening of the tenders. The tenders sealed with Gum/Staples etc, i.e. by means other than sealing wax shall not be opened.

# 2.2 Earnest Money Deposit (EMD)------ Rs 12,500/-

(SSI/PSU units are exempted for payment of EMD; However copy of their permanent registration certificate must be enclosed with tender) duly attested.

Earnest money payable with this tender has to be paid either in the form of cash at the cash counter O/O GM, Madikeri or by Crossed demand draft drawn in favour of BSNL, Madikeri TD, Payable at Madikeri. The original Cash receipt or the Crossed Demand Draft should invariably be attached to the tender offered. Earnest money paid against any other tender shall not be adjusted towards this tender and hence fresh earnest money is to be paid against this tender.

# 2.3 Security Deposit (SD)------ RS 35 ,000/-

The security deposit may be paid in the form of Demand Draft drawn in favour of BSNL, Kodagu Telecom district, Payable at Madikeri.

- 2.4 The earnest money and security deposit bears no interest and earnest money will be refunded to all the unsuccessful tenderer after the contract is finalized.
- 2.5 The security deposit shall not bear any interest and shall not be refunded to the contractor(s) until a period of 6 months after the completion of last work awarded against this tender or 3 months of completion of the contract period which ever is later.
- 2.6 The BSNL reserves the right to enhance the security deposit as and when felt necessary
- 2.7 Tenderers are required to furnish the Pre-receipt for refund of EMD to the unsuccessful tenderer

#### 3.0 FOREFEITURE OF EMD/SECURITY DEPOSIT

- 3.1 If the successful tenderer fails to remit the security deposit within 10 days of conveying the acceptance, the EMD shall stand forfeited.
- 3.2 If the contractor fails to undertake the work within stipulated period the EMD & SD shall stand forfeited.

- 3.3 If the contract is terminated by the Department due to poor quality of workmanship, negligence of the contractor, or delay in completion of work as per the work order, EMD & security deposit will be forfeited.
- 3.4 If the contractor abandons the contract, the EMD & security deposit shall stand forfeited.
- 3.5 In the event of any breach of terms and conditions of the contract, i.e delay, default or any other lapse on the part of the contractor, the contract shall be terminated without any notice and the EMD & security deposit shall stand forfeited.
- 3.6 If any document submitted by the contractor is found false or forged at any stage, the EMD and SD shall be forfeited.

#### 4.0 GENERAL TERMS AND CONDITIONS

- 1. The tenderer should visit the installations under the respective sub-divisions once in two months for routine maintenance.
- 2. The tenderer should ensure that the maintenance of card/job card are prepared for the work done and got countersigned by the officer in charge of the installation.
- 3. The tenderer should quote the rates in form at Annexure –C
- 4. GM, Madikeri reserves the right to accept more than one tender in case the rates by more than one tenderers happens to be the same
- 5. Tenderer who quotes lowest rates will be L-1
- 6. In case of discrepancy, the rates quoted in words will be taken as authentic
- 7. In addition to the existing engine alternators in Annexure-B, this contract will also be applicable for any new engine alternators (for which warranty period has been expired) added to the list of the present/new stations within the district mentioned in para 1 of the tender notice. In all cases the payment will be on the basis of bi-monthly servicing i.e. from the commencement of 1<sup>st</sup> servicing to the end of the period of contract. Successful tenderer should attend to any fault reported by the officers in charge/sub divisional engineers in charge of the installations within
- 8. 48 hours of reporting of the same, failing which the penalty will be imposed as per provisions of the "PENALTY CLAUSE", and the payment will be made only after deduction of the penalty. Payment will be made for the spares used either for the visit for clearing the fault when reported by the field officers.
- 9. The successful tenderer should:-
- a. Enter the agreement with the BSNL KODGU T.D. in the prescribed form within 10 days from the date of acceptance of Tender.
- b. Produce the certificate of registration with the assistant commissioner of Labour (central) Mangalore within one month from the award of tender if he has employed 20 or more labour for the work mentioned in the tender or otherwise he should give a declaration regarding the number of labour employed by him if he has not employed 20 or more labour.
  - 10. The EMD of the successful tenderer will be forfeited to the Government if the successful tenderer fails to complete all the formalities mentioned at clause No. 3 & 8 within the specified time.
  - 11. The payment will be made by the General Manger Telecom Kodagu Telecom District after the work is done satisfactorily and certified by the respective Sub Divisional officers/ engineers ,by crossed cheques on submission of the bills by the contractors in triplicate, duly stamped and pre-receipted to the officer in charge. The bills must be addressed to the GMT Kodagu Telecom District Madikeri and submitted through the respective Sub Divisional officers/ Engineers.
  - 11. The damage done to the equipment during servicing /fault clearance will be made good by the contractor at his cost.
  - 12. The tender will be valid for two year commencing from the date of final confirmation of the acceptance the tender. The period of contract may be extended for a further specific period by the GM, Madikeri at the same rates terms & conditions, if necessary.
  - 13. Any attempt of negotiations of bringing influence by any means for the acceptance of the tender, the tender is liable for exclusion from consideration.

14. The contractor should intimate the name of the persons who are working under him in any capacity or subsequently employed by him and who are near relatives of gazette officers of the department of telecommunications /B.S.N.L.

The liability of implementing the provision of EPF & MP Act 1952 under scheme framed there under act lies with the contractor.

- 15 The contractor shall observe all the rules regarding wages to the labours, protection of life, health and sanitary arrangements of the workers employed by him and pay the required compensation to the workers payable under the workmen compensation act 1923 for injuries or disabilities or death caused in the process of execution of the work. The tenderer/contractor will engage his labour in accordance with the labour act in force. The Tenderer/contractor is responsible for the safety and protection of the life of the labour employed by him and shall pay compensation as per act in force, for injuries or disabilities/death caused in the proceeds of execution of work. For this purpose successful tendrer has to insure all the workers for compensation under workman compensation Act with insurance company.
- 16. Contractors who have near relatives posted as Gazettes officers in Karnataka Telecom Circle are not permitted to tender against this notice inviting tender. No one connected with or in the employment of Telecom Department shall ever be admitted as a partner of the contract.
- 17. The contractor shall observe all labour regulations while employing his laborers. No laborers below the age of 18 year shall be employed on the works. In every case in which by virtue of provisions in the section 12 sub-section(1) of the workmen compensation Act 1923, where Government is obliged to pay compensation to a workman employed by the contractor for execution of the work the Government will recover the amount of the compensation so paid from the contractor by reducing from the security deposit or from any sum due from the Government to the contractor whether under this deposit or from any sum due from the Government to the contractor whether under this contract or otherwise, in such cases, the decision of the labour commissioner of the locality will be final and binding.
- 18. The contractor shall not charge any extra amount for traveling/ overtime allowances and charges for material used by him and will not be entitled to get compensation for any damage or loss in the course of execution of the work.
- 19. a) The contractor shall not assign or sublet the contract or any part thereof. The contractor shall not assign the work either directly or indirectly to any of the staff working in the department of telecom/BSNL
- b. No departmental employee can submit tender against this tender notice or can indirectly associate with circumstances.
- 20. The security deposit along with EMD furnished by him will be forfeited to the Government without prejudice to any other rights of the Government under the following circumstances.
  - a. In the event of the contractor failing to observe or perform any of the conditions of the work as setout therein.
  - b. In the case of unsatisfactory work done by the contractor.
  - c. In the event of not complying with the orders/ instructions issued by the department or with the terms and conditions of this tender notification.
  - d. In case the event of not completing the formalities mentioned at clause No. 3 to 8 above.
- 21. Conditions mentioned in the tender notice are part of the Agreement Form –C executed on a non Judicial stamp paper of Rs. 50/-

22. The GM Madikeri may terminate this agreement at his option any time by giving 30 days notice and without assigning any reasons and in the case of non standard or bad work, the GM Madikeri may remove the same and have it replaced, deducting the cost of the work rejected, or the cost of replacing the same work as he may think proper from any amount due or the cost of replacing the same work as he may think proper from any amount due or that may become due to the contractor making this tender. In the event of any damages sustained by the department due to the unsatisfactory execution or delay in carrying out the work by the selected contractor, the GM Madikeri will decide forfeiting the EMD/SD and entitled to recover the cost of the damages. In assessing the cost of the damages, the decision of the GMT Madikeri shall be final GMT reserves to himself the right to forfeit the entire security deposit or such portion thereof as he thinks fit for improper works carried out by the contractor.

#### 24. PENALTY CLAUSE AND BLACK LISTING

- 24. A) The contractor is expected to do the bi-monthly servicing work as per the schedule and should be completed within the period mentioned in the schedule for completion of the work, failing which short falls fulfilling the above conditions shall be penalized at the rate of 5% of the total value of the work per week of delay or part thereof. Subject, to a maximum of 10% of the value of the work and the bill for that work will be passed only after deduction of the penalty. If the work is not completed even after four weeks of the expiry of the date, the department has right to cancel the contract and forfeit the EMD/SD
- 24. B) Any fault or break downs should be attended within 48 hours of the reporting and the work of major break downs should be completed within 15 days from the date of reporting failing which a penalty of Rs. 50/- per day will be imposed and will be deducted from the concerned bill.
- 24 C) Failure to adhere to any of the contractual obligations will lead to the BLACK LISTING" of the contractor and he will not to be permitted to submit tenders in Kodagu Telecom District and also his name will be circulated in the entire Karnataka Telecom Circle, as a "BLACK LISTED CONTRACTOR"
- 24 D) The D.E.(A&P) will decide to impose penalty in respect of works delayed or to forfeit EMD/SD and terminate the contract and" BLACK LISTING" the contractor for not adhering to the contractual obligation.

24E) CONDONING OF DELAY WILL BE DONE BY AN OFFICER NOT BELOW THE RANK OF General Manager, TELECOM.

## 25. REPLACEMENT OF SPARES.

- 1. In case replacement of spares, the replaced spares should be made over to the concerned SDE and a certificate to that effect endorsed on the bill
- 2. All the replaced spare parts should be guaranteed for a minimum period of three months.
- 3. Date of last replacement of spares parts should be indicated on the bill

#### 26 **DOCUMENTS**
