TENDER NOTIFICATION

On behalf of BHARAT SANCHAR NIGAM LIMITED, limited sealed tenders are invited by the General Manager Telecom District Gulbarga from the manufacturers / suppliers for the supply of PCO sign boards.

TERMS AND CONDITIONS :

- 01 The description of specification is in **Annexure-1**.
02. The rate quoted should be inclusive of TAXes, Levies and packing & forwarding.
3. The Tenderer will have to deposit an Earnest Money of Rs.3000,-(Rs. three thousand)only, non interest bearing , by DD drawn on any Nationalised /scheduled Bank payable at Gulbarga drawn in favor of Accounts Officer (Cash) O/o the G M Telecom (BSNL) Gulbarga, near H P O Gulbarga-585101. OR can be paid by cash in the cash counter O/o GMTD Gulbarga and the cash receipt should be enclosed to the tender. The tender without Earnest Money Deposit (EMD) will not be considered.
- 4 EMD of the successful tenderer will be converted as security deposit. In addition to EMD already paid by the successful tenderer he has to pay Rs 3000/- as additional security deposit so that the total SD is Rs 6000/-. The EMD/SD while in custody of BSNL, will not carry any interest. The successful Tenderer has to enter into an agreement on a Stamp Paper of Rs 100/-.
- 5 Earnest Money Deposit (EMD) of the successful tenderer is liable to be forfeited, if the tenderer rescinds from the offer OR fails to enter into an agreement. EMD of unsuccessful Tenderer will be refunded after the finalisation of tender on production of pre-stamped receipt, or within two months from the date of opening of tender whichever is earlier.
- 6 The Tender cover should be superscribed as “**TENDER FOR SUPPLY OF PCO SIGN BOARDS** ” and should be addressed to **SRI.T.Kallappa** AGM (PLG) O/O THE G M T D Gulbarga, Near H P O GULBARGA – 585101.and it should be put into the tender box kept in the chamber of **AGM (PLG) O/O the GMT Gulbarga**.
- 7 The tender forms will be issued by the S D E (Plg) O/O the GMTD Gulbarga on all the working days up-to **12-30hrs of 12-10-09**.on payment of Rs.563/-(500+TAX) (Rs Five hundred Sixty three only) at Cash Counter O/o the GMTD Gulbarga. or tender form may be down loaded from website www.karnataka.bsnl.co.in The DD for Rs 563 /-(Five hundred sixty three) only drawn in favor of A.O. Cash O/o GMTD BSNL Gulbarga for down loaded tender documents should be enclosed
- 8 The last date for acceptance of tender forms is **12.10.2009 up to 1500 hours**. The tender will be opened on the same day **at 1530 hours** in the chamber of AGM(PLG) & in the presence of the tenderers OR their representatives if any. Only one person per tender will be allowed to attend for tender opening.
- 9 **ELIGIBILITY: Manufacturers/suppliers** and the necessary documents should be enclosed to the tender for showing evidence of the same.
- 10 The contractor shall not assign OR sublet the work.

- 11 Each page of the tender schedule and annexure should be signed by the tenderer. Also any correction made should be signed by the tenderer.
- 12 If, the last date for receipt of tender happens to be a holiday the same will be extended to the next working day at the same time.
- 13 The quantity of requirement is 4000 Nos **approximately, it may vary + / - 25%.**
- 14 The General Manager Telecom District Gulbarga reserves the right to reject any or all tenders received without assigning any reasons and will not be bound to accept the lowest tender
- 15 The General Manager Telecom District Gulbarga reserves the right to engage more than one contractor to meet the time schedule for the supply.
- 16 After the acceptance of tender, if the tenderer fails to enter into the agreement, the tenderer is liable to be blacklisted and will not be allowed to participate in the future tenders and his EMD/SD will be forfeited.
- 17 The successful tenderer should enter into an agreement on Rs.100/- (Rs one hundred) stamp paper. The cost of the stamp paper should be borne by the contractor.
- 18 The tenderer not confirming to the above conditions will be rejected.
- 19 In case of breach of any of the conditions, the tender is liable to be cancelled, resulting in forfeiture of EMD / Security deposit.
- 20 The decision of the General Manager Telecom Gulbarga is final and binding on all the contractors.
- 21 **VALIDITY.** The tender will be valid for one year from the date of issue of final award or till the completion of the supply of entire quantity. No escalation will be allowed during this period.
- 22 **PAYMENT :** 90% Payment will be made after satisfactory supply of PCO sign boards and balance 10% after of ONE Year.
- 23 **PENALTY.** The contractor should supply the materials within 15 days of period mentioned in the purchase order. Failing which a sum of Rs, 40/- (Rs, forty) per day will be charged as penalty up-to the maximum of Rs. 300/- (Rsthree hundred only per PO. If the contractor fails to supply the materials within seven days after the lapse of delivery period the contract will be cancelled and SD will be forfeited.
- 24 **WARRANTY.** Any deficiencies/defects during the first six months of it's usage ,the contractor shall resupply PCO sign boards at his cost.
25. The contractor has to enclose the declaration in the proforma mentioned in the appendix
